**B**E it enacted by His Excellency the Governor and  
Commander-in-Chief of the Colony of Cyprus as  
follows:—

1. This Law may be cited as the Special Court Laws (Repeal) Law, 1960, and shall come into operation on the 27th July, 1960. Short title and commencement.

2. The Special Court Laws, 1955 to 1959, are hereby repealed. Repeal.

**A LAW TO MAKE FURTHER PROVISION REGARDING THE CONSTITUTION OF THE ELECTRICITY AUTHORITY OF CYPRUS AND FOR THIS PURPOSE TO AMEND THE ELECTRICITY DEVELOPMENT LAWS, 1952 TO 1954.**

**B**E it enacted by His Excellency the Governor and Commander-in-Chief of the Colony of Cyprus as follows :—

Short title.

1. This Law may be cited as the Electricity Development (Amendment) Law, 1960, and shall be read as one with the Electricity Development Laws, 1952 to 1954 (hereinafter referred to as " the principal Law " ).

Amendment

2. The principal Law is hereby amended—

(a) by deleting subsection (1) of section 5 and substituting therefor the following : —

" (1) The Authority shall consist of not more than seven members appointed by the Governor (hereinafter referred to as ' the members ' ), one of whom shall be designated by the Governor as Chairman and another as Vice-Chairman :

Provided that the members need not be persons whose full time services shall be required." ;

(b) by substituting for the expression " Deputy Chairman " wherever it occurs in the principal Law the expression " Vice-Chairman " ;

(c) by substituting for the expression " appointed members " or " appointed member " wherever they occur in the principal Law, the expression " members " or " member ", as the case may be ;

(d) by substituting for the word " two " occurring in the second line of subsection (1) of section 8 the word " four " .

3. On the appointment of the members of the Authority under the provisions of the principal Law, as amended by this Law, the Electricity Development Law, 1959, shall cease to have effect.
