TURKISH FAMILY (MARRIAGE AND DIVORCE) RULES.

RULES MADE UNDER SECTION 50.

- 1. These rules may be cited as the Trukish Family (Marriage and Divorce) Rules.
- 2. Every marriage officer shall keep a marriage register which shall be numbered consecutively and shall be as in the Form A in the Appendix hereto.
- 3. A consent under section 6 of the Law, a notice of marriage under section 11 of the Law, a certificate of notice of marriage under section 14 (1) of the Law and a certificate of marriage under section 14 (3) of the Law shall be as in the Forms B, C, D and E in the Appendix hereto, respectively.
