An Ordinance to make provision in connection with the Treaty of Lisbo9n amending the Treaty of European Union and the Treaty establishing the European Community, signed at Lisbon on 13<sup>th</sup> December 2007

Be it enacted by the Administrator of the Sovereign Base Areas of Akrotiri and Dhekelia as follows:-

#### Short Title

1. This Ordinance may be cited as the European Union Ordinance 2010.

#### Interpretation

2. In this Ordinance and in every other Ordinance and in all public instruments, (a) the following words and expressions have the meanings assigned to them respectively unless the context otherwise requires-

"the EU" means the European Union, being the Union established by the Treaty on European Union signed at Maastricht on 7 February 1992 (as amended by any later Treaty);

"the European Court" means the Court of Justice of the European Union;

"the TFEU" means the Treaty on the Functioning of the European Union (the Treaty establishing (what was then called) the European Union Community, signed at Rome on 25 March 1957 (renamed b the Treaty of Lisbon));

"the Treaty of Lisbon" means the Treaty of Lisbon Amending the Treaty on European Union and the Treaty Establishing the European Community signed at Lisbon on 13 December 2009.

#### **Changes of Terminology**

3. In an Ordinance or public instrument a reference to—

- (a) the European Community or the European Communities is to be treated as being or including (as the context requires) a reference to the EU;
- (b) the EC Treaty or a specific provision of the EC Treaty is to be treated as a reference to the TFEU or the equivalent provision of the TFEU as set out in the table of equivalences in the Annex to the Treaty of Lisbon.

#### European Community (Protocol Measures) Ordinance 2004 amended (b)

**4.** Section 1 of the European Community (Protocol Measures) Ordinance 2004(c) is repealed and replaced by the following-

#### "1. Short title

This Ordinance may be cited as the European Union (Protocol Measures) Ordinance 2004.".
