ORDINANCE 19 OF 1980.

AN ORDINANCE

TO AMEND THE PETROLEUM SALES (REGULATION)
ORDINANCE, 1979.

BE it enacted by the Administrator of the Sovereign Base Areas of Akrotiri and Dhekelia as follows:—

1. This Ordinance may be cited as the Petroleum Sales (Regulation) (Amendment) Ordinance, 1980 and shall be read as one with the Petroleum Sales (Regulation) Ordinance, 1979 (hereinafter referred to as “the principal Ordinance”).

Short title.

Ordinance 4/79.

2. Section 3 of the principal Ordinance is hereby amended by deleting subsection (1) thereof and substituting therefor the following new subsection:—

Section 3

“(1) All petrol stations shall be closed and shall not operate in any manner:—

- (a) On weekdays during the period 1st April to 30th September of every year except between the hours of 6 a. m. and 7 p. m. ;
- (b) on weekdays during the period 1st October to 31st March of every year except between the hours of 6 a. m. and 6 p. m. ;
- (c) on Sundays at all times ;
- (d) on Saturdays except between the hours of 6 a. m. and 4 p. m.”.

AN ORDINANCE

**TO AMEND THE INDUSTRIAL TRAINING AUTHORITY
(REPUBLIC OF CYPRUS) (RECOGNITION) ORDINANCE, 1979.**

BE it enacted by the Administrator of the Sovereign Base Areas of Akrotiri and Dhekelia as follows :—

Short title.

1. This Ordinance may be cited as the Industrial Training Authority (Republic of Cyprus) (Recognition) (Amendment) Ordinance, 1980 and shall be read as one with the Industrial Training Authority (Republic of Cyprus) (Recognition) Ordinance, 1979 (hereinafter referred to as "the principal Ordinance").

Ordinance 1/79.

Section 2 of the principal Ordinance amended.

2. Section 2 of the principal Ordinance is hereby amended by repealing the definition "emoluments" thereof and substituting therefor the following new definition :

" 'emoluments' includes any monetary remuneration from the employment of an employee or any profit from such employment having a monetary value which cannot be ascertained, and in addition it includes the contributions payable to the Fund established under the Annual Holidays with Pay Ordinance, 1973 excluding special commissions and ex-gratia payments ; ".

Section 13 of the principal Ordinance amended.

3. Section 13 of the principal Ordinance is hereby amended by repealing subsection (2) thereof and substituting therefor the following new subsection :—

"(2) Any person who contravenes or fails to comply with any other provision of this Ordinance shall be guilty

of an offence and on conviction shall be liable to imprisonment not exceeding six months or to a fine not exceeding three hundred pounds or to both such imprisonment and fine".

Commencement.

4. Section 2 of this Ordinance shall be deemed to have come into effect on the 6th October, 1980.

AN ORDINANCE

TO AMEND THE ANNUAL HOLIDAYS
WITH PAY ORDINANCE, 1973.

BE it enacted by the Administrator of the Sovereign Base Areas of Akrotiri and Dhekelia as follows:—

1. This Ordinance may be cited as the Annual Holidays with Pay (Amendment) Ordinance, 1980 and shall be read as one with the Annual Holidays with Pay Ordinance, 1973 as amended by the Annual Holidays with Pay Ordinance (Amendment) Ordinance, 1979 (hereinafter referred to as "the principal Ordinance").

Short title.

Ordinances 10/73 and 12/79.

2. Section 9 of the principal Ordinance is hereby amended:

Section 9 of the principal Ordinance amended.

(a) by deleting the full stop at the end of paragraph (d) thereof and substituting therefor a semi colon; and

(b) by inserting immediately after paragraph (d) thereof the following new paragraph, to be lettered (e):—

“(e) the imposition of liability to imprisonment not exceeding six months or to a fine not exceeding three hundred pounds or to both such imprisonment and fine in respect of offences related to the collection of contributions to the Fund and the payment of benefits therefrom.”

3. Section 13 of the principal Ordinance is hereby amended by repealing the word “fifty” appearing in the tenth line thereof and substituting therefor the words “two hundred and fifty”.

Section 13 of the principal Ordinance amended.

4. Section 14 of the principal Ordinance is hereby amended:—

Section 14 of the principal Ordinance amended.

(a) by repealing the words “one hundred pounds or to imprisonment not exceeding three months or to both such fine and imprisonment” appearing at the end of subsection (1) thereof and substituting therefor the words “three hundred pounds or to imprisonment not exceeding six months or to both such fine and imprisonment.”; and

(b) by repealing the words “fifty pounds” appearing at the end of subsection (2) thereof and substituting therefor the words “three hundred pounds or to imprisonment not exceeding six months or to both such fine and imprisonment.”
