ORDINANCE 3 OF 1988.

#### AN ORDINANCE

TO AMEND THE ESTATE DUTY (AMENDMENT)
ORDINANCE, 1987.

**BE** it enacted by the Administrator of the Sovereign Base Areas of Akrotiri and Dhekelia as follows:—

1. This Ordinance may be cited as the Estate Duty (Amendment) Ordinance, 1988.

Short title.

2. The Estate Duty (Amendment) Ordinance 1987 is hereby amended by repealing Section 6 thereof and substituting therefor the following new Section:—

Section 6 of the Estate Duty (Amendment) Ordinance 1/87, repealed and replaced.

"6. This Ordinance shall apply to the estate of any person who died on or after the 1st July, 1985.".

#### AN ORDINANCE

TO ASSIST IN THE ENFORCEMENT IN THE SOVEREIGN BASE AREAS
OF CERTAIN PROVISIONS OF THE CHILD ALLOWANCE LAW
OF THE REPUBLIC OF CYPRUS.

**BE** it enacted by the Administrator of the Sovereign Base Areas of Akrotiri and Dhekelia as follows:—

Short title.

1. This Ordinance may be cited as the Republican Child Allowance Law (Relevant Provisions) (Enforcement) Ordinance, 1988.

Interpretation.

2. In this Ordinance, unless the context otherwise requires:—

Ordinance 6 of 1960. "Cypriot" has, subject to the provisions of Section 3 of this Ordinance, the same meaning as in the Citizens of the Republic (Jurisdiction of Courts) Ordinance, 1960;

"entitled person" means any person whatever his or her personal status who is a parent or is in charge, of at least four dependent children as defined in the Republican Law;

"Registrar" means a Senior Registrar or Registrar of either Court of the Sovereign Base Areas;

Law 314/87 (Cyprus).

"Republican law" means the Child Allowance Law of the Republic.

Recognition in the Areas of civil proceedings to enforce Republican Law. 3. Any civil proceedings against any entitled person being a Cypriot to compel such entitled person to return to any Authority of the Republic, money which it is alleged such person has received from the Revenue of the Republic or any Authority operating under any legislation of the Republic, (being money to which he is not entitled but which it is alleged has been paid to him in good faith under the provisions of the Republican law) shall be treated as if such proceedings are recognised proceedings for the purposes of Part III of the Citizens of the Republic (Jurisdiction of Courts) Ordinance, 1960 and the plaintiff whether an individual person or not, if purporting to be an Authority of the Republic, shall be treated for such purposes as a Cypriot.

4. Any benefit lawfully payable under the Republican law to an entitled person, shall be exempt from any legislation of the Areas relating to income tax to the like extent as it is exempt under the provisions of the Republican law from similar legislation of the Republic.

Benefit payable under Republican Law to be exempt from Income Tax. 5.—(1) Any person who within or from the Areas for the purpose of securing a benefit for either himself or another person for any reason relating to the Republican law:—

Penal provisions.

- (a) intentionally or by reason of negligence or carelessness makes a false report or false representation; or
- (b) presents, furnishes, causes or allows the presentation or supply of documents or information directly or indirectly to any Authority of the Republic knowing the said documents or information to be false,

shall be guilty of an offence punishable on conviction by a fine not exceeding one thousand pounds or by imprisonment not exceeding two years or by both such imprisonment and fine.

- (2) No prosecutions shall be instituted under the provisions of this Section without the written approval of the Legal Adviser.
- (3) In any proceedings under the provisions of this Section, the Court may take judicial notice of the Republican law and of any English translation thereof or any part thereof stated in Court or certified as being accurate by a Registrar.

- 2. Section 27 of the principal Ordinance is hereby amended by deleting paragraph (a) thereof and the proviso thereto.
- 3. This Ordinance shall be deemed to have come into effect on the 1st July, 1987.

1. This Ordinance may be cited as the Courts (Amendment) Ordinance, 1988 and shall be read as one with the Courts Ordinance as amended from time to time (hereinafter referred to as "the principal Ordinance").

2. Section 21 of the principal Ordinance is hereby amended by deleting the words "two thousand pounds" appearing in the third line of subsection (2) thereof and substituting therefor the words "three thousand pounds".

3. Section 38 of the principal Ordinance is hereby amended by inserting at the end thereof the following sentence:—

"Such costs may include interest as the Court in the exercise of its discretion may consider just.".

# TO AMEND THE STREET AND HOUSE TO HOUSE COLLECTIONS ORDINANCE.

# ADMINISTRATOR

BE it enacted by the Administrator of the Sovereign Base Areas of Akrotiri and Dhekelia as follows:—

Short title. (Cap. 95—Laws of Cyprus).

1. This Ordinance may be cited as the Street and House to House Collections (Amendment) Ordinance, 1988 and shall be read as one with the Street and House to House Collections Ordinance (hereinafter referred to as "the principal Ordinance").

Long title of the principal Ordinance amended.

2. The long title of the principal Ordinance is hereby amended by deleting thereof the words "Street and House to House Collections" and substituting therefor the words "Carrying out of Collections".

Section 1 of the principal Ordinance amended. 3. Section 1 of the principal Ordinance is hereby amended by deleting in the first and second line thereof the words "as the Street and House to House Collections Ordinance" and substituting therefor the words "as the Carrying out of Collections Ordinance".

Section 2 of the principal Ordinance amended. 4. Section 2 of the principal Ordinance is hereby amended by deleting the definitions of "collection", "Collector", "house" and "Licensing Authority" appearing therein and substituting therefor the following new definitions:—

"collection" means an appeal to the public or any class of the public made by means of visits from house to house or of soliciting expressly or tacitly in any place (other than a place of worship or a dwelling house in which the collector is resident or an invited guest) or by letter, announcement, publication, document or by use of a postal service, the press, the telephone, the radio or television, to give money or other property whether for consideration or not, to the collector or to any other person or body of persons or organisation whether corporate or incorporate, not being money or property due or about to fall due from the donor by reason of any enactment, contract or other legal obligation;

"collector" means in relation to a collection, a person who makes such an appeal by any of the said means;

"house" includes a place of business or work or a mess or club:

Provided that the reference to dwelling house in the definition of "collection" shall not include a mess.

# "Licensing Authority":-

- (a) within any Military Garrison or Royal Air Force Station (other than a public road), means the Fiscal Officer; and
- (b) within any other part of the Areas including public roads, means the Area Officer of the respective Area.
- 5. Section 3 of the principal Ordinance is hereby amended:—

Section 3 of the principal Ordinance amended.

- (a) by deleting in the third line of subsection (1) thereof the words "to the Commissioner as Chairman of" and substituting therefor the word "to"; and
- (b) by deleting in the second and third lines of subsection (3) thereof the words "the Commissioner as Chairman of".
- 6. Section 4 of the principal Ordinance is hereby amended by deleting in the eighth line of paragraph 2 of Section 4 thereof the words "one hundred pounds" and substituting therefor the words "three hundred pounds".

Section 4 of the principal Ordinance amended.

7. Section 7 of the principal Ordinance is hereby amended by inserting in the fifth line of Section 7 immediately after the words "or other property" a comma and the words "and any article, emblem, receipt stamp, document, book, counterfoil or other printed matter which relates to or may be relevant to such offence."

Section 7 of the principal Ordinance amended.

8. Section 9 of the principal Ordinance is hereby amended by deleting in the third line of subsection (1) thereof the words "twenty five pounds" and substituting therefor the words "one hundred pounds".

2. Section 2 of the principal Ordinance is hereby amended by deleting the definition of "road" appearing therein.
