ORDINANCE 18 OF 1988.

AN ORDINANCE

TO AMEND THE STREETS AND BUILDINGS REGULATION
(CONSOLIDATION) ORDINANCE, 1984.

BE it enacted by the Administrator of the Sovereign Base Areas of Akrotiri and Dhekelia as follows:—

1. This Ordinance may be cited as the Streets and Buildings Regulation (Consolidation) (Amendment) Ordinance, 1988 and shall be read as one with the Streets and Buildings Regulation (Consolidation) Ordinance, 1984 as amended from time to time (hereinafter referred to as “the principal Ordinance”).

2. Section 3 of the principal Ordinance is hereby amended by deleting existing paragraph (e) of subsection (1) thereof and substituting therefor the following new paragraph:—

“(e) alter or permit or suffer the alteration of the approved use of the building.”.

3. Section 23 of the principal Ordinance is hereby amended:—

(a) by deleting the full stop at the end of paragraph (b) of subsection (3) thereof and substituting therefor a semicolon;

(b) by inserting immediately after paragraph (b) of subsection (3) thereof the following paragraph to be lettered (c):—

“(c) where the approved use of a building is being altered, the stoppage of the alteration of the approved use of the building, within such time as shall be specified in the Court order, but in no case exceeding two months, unless a permit is obtained in respect thereof, in the meantime, from the appropriate authority.”.

(c) by inserting immediately after the word "street" in the fourth line of subsection (4) thereof the following:—

"or the alteration of the approved use of a building".

AN ORDINANCE

TO AMEND THE LAND ACQUISITION ORDINANCE.

BE it enacted by the Administrator of the Sovereign Base Areas of Akrotiri and Dhekelia as follows:—

1. This Ordinance may be cited as the Land Acquisition (Amendment) Ordinance, 1988 and shall be read as one with the Land Acquisition Ordinance, as amended from time to time (hereinafter referred to as the “principal Ordinance”).

Short title.

Cap. 226 (Laws of Cyprus) Ordinances 12/63, 9/64, 1/86 and 4/87.

2. Section 7A of the principal Ordinance is hereby amended by deleting subsection (2) thereof and substituting therefor the following new subsection:—

Section 7A of the principal Ordinance amended.

“(2) Where an order of acquisition in respect of any property or any part of any property, referred to in any notice of acquisition, is not published within ten months from the publication of such notice in the Gazette, or if within ten months from the publication of such notice compensation estimated is not offered, the proceedings consequential to such notice shall abate and the acquisition of the said property or part of property, as the case may be, shall be deemed to have been abandoned.”
