ORDINANCE 17 OF 1990.

## AN ORDINANCE

TO AMEND THE ELECTRICITY ORDINANCE.

**ADMINISTRATOR** 

**BE** it enacted by the Administrator of the Sovereign Base Areas of Akrotiri and Dhekelia as follows:—

1. This Ordinance may be cited as the Electricity (Amendment) (No. 1) Ordinance, 1990 and shall be read as one with the Electricity Ordinance (hereinafter referred to as "the principal Ordinance").

Short title.

- Cap. 170—(Laws of Cyprus).
- **2.** Section 67 of the principal Ordinance is hereby amended as follows:—

Section 67 of the principal Ordinance amended.

- (a) by numbering the existing part thereof as subsection (1);
- (b) by deleting the full stop appearing at the end of subsection (1) thereof and substituting therefor a semi-colon, to be followed by the new paragraphs shown hereunder:—
  - "(e) to carry out, if so required by the competent authority, an inspection of the electrical installation and the electrical equipment of any premises for determining whether and to what extent the said installation and equipment are in accordance with the provisions of this Ordinance and the Regulations made thereunder.";
  - (f) to examine and test any electrical equipment for determining whether such equipment is in accordance with the provisions of this Ordinance and the Regulations made thereunder.";
- (c) by inserting immediately after subsection (1) thereof, the following new subsection:—-

"(2) In this Section—

"competent authority" means the Area Officer of the Sovereign Base Area within which the said premises are situated;

"electrical equipment" includes any electro-engine, any generator, any motor, any transformer, any electrical apparatus whether portable or not, any instrument for measuring electrical energy, any protective matter, any wiredrawing matter, any electrical accessory and any object which is used for the production, transformation, transmission, distribution, exploitation or use of electric energy."

Section 69 of the principal Ordinance amended.

- 3. Section 69 of the principal Ordinance is hereby amended as follows:—
  - (a) by inserting at the commencement of subsection (2) thereof, the words, "Except as provided in subsection (3) of this Section,";
  - (b) by inserting immediately after subsection (2) thereof the following new subsection:—
    - "(3) Notwithstanding the provisions of subsection (2) of this Section, the consumer or the proprietor of any premises in which an automatic cut-out (M.C.B. Main Circuit Breaker) has been installed by the undertakers, shall be deemed to have been authorised by them to operate the said installation for the purpose of restoring the supply of electricity and such authorisation shall not constitute a contravention of the provisions of subsection (2).".
