ORDINANCE 16 OF 1992

AN ORDINANCE
TO AMEND THE CIVIL WRONGS ORDINANCE.

BE it enacted by the Administrator of the Sovereign Base Areas of Akrotiri and Dhekelia as follows :-

1. This Ordinance may be cited as the Civil Wrongs (Amendment) Ordinance, 1992 and shall be read as one with the Civil Wrongs Ordinance, as amended from time to time (hereinafter referred to as "the principal Ordinance.").

Short title.
Cap. 148 (Laws of Cyprus) and Ordinances 2/74, 11/78, 2/86 and 7/89.

2. Section 58 of the principal Ordinance is hereby amended -

(a) by deleting paragraph (b) of subsection (8) thereof and substituting therefor the following:-

"(b) where the deceased had not attained the age of twenty five and was never married -

(i) of his parents, if he was a legitimate child; and

(ii) of his mother, if he was an illegitimate child. "; and

(b) by deleting the figure "£3,000" appearing in subsection (9) thereof and substituting therefor the figure "£6,000".

3. The provisions of Section 2 above shall apply only in respect of civil wrongs occurring after the date of publication of this Ordinance in the Gazette.

AN ORDINANCE
TO AMEND THE CUSTOMS AND EXCISE
DUTIES ORDINANCE

BE it enacted by the Acting Administrator of the Sovereign Base Areas of Akrotiri and Dhekelia as follows:-

Short title.

1. This Ordinance may be cited as the Customs and Excise Duties (Amendment) Ordinance, 1992 and shall be read as one with the Customs and Excise Duties Ordinance, 1989 as amended from time to time (hereinafter referred to as "the principal Ordinance").

Third Schedule to

2. The Third Schedule to the principal Ordinance is hereby amended by repealing the second proviso to classes A7 and B2 appearing in the second column thereof and substituting therefor the following new proviso:-

"Provided further that for the motor vehicles referred to hereunder, the excise duty payable shall be at a rate of only 15% ad valorem:-

- (a) Motor vehicles of the "go cart" type, used exclusively in enclosed and/or surrounded places for amusement purposes;
- (b) amphibious motor vehicles, of a gross weight not exceeding 1000 kilograms, having three rows of wheels with motion in all such wheels, such motor vehicles being used for either recreational or business purposes, being able to carry two to four persons;
- (c) motor vehicles of the "Hovercraft" type which are so constructed as to be able to move over the water as well as on the ground; and
- (d) motor vehicles which are propelled by an electric motor, the power of which does not exceed 10 kilowatts, used for the purpose of transporting passengers."
