ORDINANCE 5 OF 1996

AN ORDINANCE
TO AMEND THE IMMOVABLE PROPERTY (TENURE,
REGISTRATION AND VALUATION) ORDINANCE.

BE it enacted by the Administrator of the Sovereign Base Areas of Akrotiri and Dhekelia as follows:-

1. This Ordinance may be cited as the Immovable Property (Tenure, Registration and Valuation) (Amendment) (No. 2) Ordinance, 1996 and shall be read as one with the Immovable Property (Tenure, Registration and Valuation) Ordinance as amended from time to time (hereinafter referred to as "the principal Ordinance").

Short title.

Cap.224 (Laws of Cyprus) and Ordinances 12/66, 11/84, 1 and 12/85, 5 and 18/87, 21/88, 8 and 14/90, 13/93 and 4/96.

2. The principal Ordinance is hereby amended by inserting immediately after Section 10 thereof the following new Section to be numbered 10A:

New Section 10A added to the principal Ordinance.

No title by adverse possession to certain immovable property.

"10A. Notwithstanding the provisions of Section 10 of the Ordinance, no title to any immovable property within the Areas which is inaccessible to its owner by reason of the conditions prevailing in the Island of Cyprus since 20th July 1974 shall be acquired by adverse possession".
