An Ordinance to further amend the Increments of Pay and Cost of Living Allowance (Crown Employees and Pensioners) Ordinance 2012

BE it enacted by the Administrator of the Sovereign Base Areas of Akrotiri and Dhekelia as follows:–

Short title and commencement

1.—(1) This Ordinance may be cited as the Increments of Pay and Cost of Living Allowance (Crown Employees and Pensioners) (Amendment) Ordinance 2016.

(2) This Ordinance comes into force on 30 December 2016.

Amendment of the increments of Pay and Cost of Living Allowance (Crown Employees and Pensioners) Ordinance 2012

2. The Increments of Pay and Cost of Living Allowance (Crown Employees and Pensioners) Ordinance 2012(a) is amended as follows.

Amendment of section 1 (short title and commencement)

3.—(1) In section 1(3) for “31 December 2016”, substitute “31 March 2017”.

(2) In section 1(4) for “31 December 2016”, substitute “31 March 2017”.

(a) Ordinance 9/2012, amended by Ordinance 20/2013.

Amendment of section 2 (interpretation)

4. In section 2(1), in the definition of “Relevant Period”, for “31 December 2016”, substitute “31 March 2017”.

Amendment of section 5 (service during Relevant Period does not count for increments)

5. In section 5(2)(b), for “1 January 2017”, substitute “1 April 2017”.

Amendment of section 11 (review)

6. In section 11, for “1 January 2017”, substitute “1 April 2017”.

EXPLANATORY NOTE

(This note is not part of the Ordinance)

1. This explanatory note relates to the Pay and Cost of Living Allowance (Crown Employees and Pensioners) (Amendment) Ordinance 2016 the Ordinance). It has been prepared by the Office of the Attorney General and Legal Adviser in order to assist the reader of that Ordinance. It does not form part of it.
2. This note should be read in conjunction with the Ordinance. It is not, and is not meant to be, a comprehensive description of it.
3. The Ordinance amends the Increments of Pay and Cost of Living Allowance (Crown Employees and Pensioners) Ordinance 2012 (Ordinance 9/2012).

For those Crown employees and pensioners to whom Ordinance 9/2012 applies, the Ordinance extends the period during which incremental progression, cost of living allowance and pensions are frozen, until 31 March 2017.
