FIXED PENALTY (AMENDMENT) (NO.2) ORDINANCE 2022

An Ordinance to amend the Fixed Penalty Ordinance 2010.

BE it enacted by the Administrator of the Sovereign Base Areas of Akrotiri and Dhekelia as follows:—

Short title

1. This Ordinance may be cited as the Fixed Penalty (Amendment) (No. 2) Ordinance 2022.

Commencement

2. This Ordinance comes into force on 1 December 2022.

Amendment of the Fixed Penalty Ordinance 2010

3. The Fixed Penalty Ordinance 2010 (1) is amended as follows.

Amendment of section 4 (criminal proceedings and increase of fixed penalty after serving of notice)

- **4.** In section 4 (criminal proceedings and increase of fixed penalty after serving of notice)—
 - (a) in paragraph (a) for "30" substitute "45",
 - (b) in paragraph (b) for "15" substitute "30",
 - (c) in paragraph (c) for "30" substitute "45".

6. In Schedule 2, in item 68, for "€59" substitute "€300".

EXPLANATORY NOTE

(This note is not part of the Ordinance)

- **1.** This explanatory note relates to the Fixed Penalty (Amendment) (No.2) Ordinance 2021 ("the Ordinance"). It has been prepared by the Office of the Attorney General and Legal Adviser in order to assist the reader of the Ordinance. It does not form part of the Ordinance.
 - 2. The amendments are intended to mirror fixed penalties set by the Republic of Cyprus.
 - 3. Sections 3 to 6 amend the Fixed Penalty Notice Ordinance 2010 ("the principal Ordinance").
- **4.** Section 4 amends section 4 of the principal Ordinance. It increases the number of days before which proceedings can be instituted after service of notice. It also increases the number of days a person has to pay a fixed penalty notice before it increases by 50%.
- **5.** Section 5 amends schedule 1 of the principal Ordinance. It increases fines for several offences and adds fixed penalties for various road traffic offences.
- **6.** Section 6 amends schedule 2 of the principal Ordinance by increasing the fine for selling alcohol to minors.
