**THE MINES AND QUARRIES (REGULATION)
ORDINANCE**

(Cap. 270 - Laws of Cyprus and Ordinance 14 of 1963).

REGULATIONS MADE UNDER SECTION 47.

In exercise of the powers vested in him by section 47 of the Mines and Quarries (Regulation) Ordinance and of all other powers enabling him in that behalf, the Administrator hereby makes the following regulations:-

1. These regulations may be cited as the Mines and Quarries (Amendment) Regulations, 1965, and shall be read as one with the Mines and Quarries Regulations, 1958 and 1964, (hereinafter referred to as "the principal Regulations") and the principal Regulations and these regulations may together be cited as the Mines and Quarries Regulations, 1958 to 1965.

2. Regulation 4 of the Mines and Quarries (Amendment) Regulations 1964 is hereby revoked.

3. Regulation 8 of the principal Regulations is hereby amended by adding immediately after paragraph (4) thereof the following new paragraph:-

"5. Expenditure in force immediately before the 25th June, 1964, shall continue to apply to any prospecting permit granted before that date but expenditure in respect of any renewal of any such permit or in respect of any new permit granted on or after that date shall be the expenditure prescribed by this Regulation."

4. Paragraph 4 of the Second Schedule of the principal Regulations is hereby amended by adding at the end thereof the following proviso:-

"Provided that where the extent of the area is less than 100 donums the rent shall be £25."

5. Paragraphs A and B of the Second Schedule of the principal Regulations are hereby revoked, paragraphs C and D being renumbered A and B respectively.

6. Paragraph A (as renumbered by these Regulations) of the Second Schedule of the principal Regulations is hereby amended by adding at the end thereof the following proviso:-

"Provided that the provisions in this paragraph shall not apply where the quarry materials obtained from any such Crown land are exported out of the Island of Cyprus."

7. The Second Schedule of the principal Regulations is hereby amended by adding immediately after paragraph B thereof (as renumbered by these Regulations) the following new paragraph:-

"C. Rents in force before the 25th June 1964 shall continue to apply to any permit, licence or lease granted before that date but rents in respect of any renewal of any such permit, licence or lease made, or in respect of any new permit, licence or lease granted, on or after that date shall be the rents prescribed by this Schedule.

Provided that any renewal of a prospecting permit granted before the 25th June, 1964 which takes place for the first time before that date, insofar as the payment of rents is concerned, shall be deemed to be a first renewal of such permit."

8. These Regulations shall be deemed to have come into operation on the 25th June 1965.

NOTICE UNDER REGULATION 20 (d).

In exercise of the powers conferred upon me by paragraph (d) of Regulation 20 of the Agricultural Produce (Export) Regulations 1956 to 1959, as applied to and adapted in the Areas by the Laws (Adaptation and Interpretation) Ordinances 1960 to 1962, I, the Chief Officer, Sovereign Base Areas, hereby give notice that the dates specified below are fixed for the picking of the 1965/1966 grapefruit and oval oranges intended for export:-

Grapefruit Friday, 12th November, 1965.

Oval oranges Wednesday, 17th November, 1965.
