THE HIRE PURCHASE, CREDIT SALE  
AND HIRING OF PROPERTY (CONTROL) ORDINANCE

(Ordinance No. 13 of 1966).

---

CONTROL ORDER UNDER SECTION 3.

---

In exercise of the powers conferred upon him by section 3 of the Hire Purchase, Credit Sale and Hiring of Property (Control) Ordinance, 1966, the Administrator hereby orders as follows:—

1. This Order may be cited as the Hire Purchase and Credit Sale (Movable Property) (Control) Order, 1967.

2.—(1) The property specified in the first column of the first Schedule to this Order shall be controlled property for the purpose of hire purchase or credit sale agreement. Each of the minimum percentages set out in the second column of the said first Schedule is hereby specified in relation to each respective item of property set out in the said first column opposite each respective minimum percentage for the purposes of sub-paragraph (1) of paragraph 3 of Part I of the Schedule to the Ordinance.

(2) Each of the maximum periods set out in the third column of the said Schedule is hereby prescribed in relation to each respective item of property set out in the said first column opposite each respective maximum period for the purposes of paragraph 4 of the said part of the said Schedule to the Ordinance.

3. This Order shall not apply to:—

- (1) disposal by a person otherwise than in the course of carrying out, or assisting in carrying out, the business of a shop keeper or wholesale trader, or any other commercial enterprise;
- (2) disposal of property which has been imported into the Areas from outside the Island of Cyprus, at a cash price of less than £ 20;
- (3) disposal of property to persons who are neither citizens of the Republic nor permanently resident in the Island of Cyprus.

4. A person who disposes of any of the items of property specified in the first column of the First Schedule to this Order under a hire purchase or credit sale agreement shall—

- (a) maintain a register as set out in the Second Schedule to this Order and send a copy thereof in respect of each month not later than fifteen days from the end of such month to the Fiscal Officer;

- (b) send to the Fiscal Officer in respect of each month not later than fifteen days from the end of such month a statistical return as set out in the Third Schedule to this Order;
- (c) permit the proper officer of the Administration to check the accounting records and any other documents relating to the disposal of such items for the purpose of ensuring compliance with the provisions of this Order;
- (d) provide the Fiscal Officer with appropriate particulars for the registration of such person in a special register whenever the Fiscal Officer so requires.

## EXPLANATORY NOTE

Col (1) The number and date of each agreement in writing entered into should be recorded. Copies of such agreements should be numbered and filed for reference purposes.

Col (4) The following particulars should be recorded—

- (a) detailed description of the goods sold;
- (b) the cash selling price of the goods;
- (c) the agreed price for disposal by hire purchase or credit sale.

Col (5) Where applicable the value of second-hand goods accepted against the amount payable in advance should be recorded, the following particulars being recorded—

- (a) detailed description of such goods;
- (b) purchase price;
- (c) page of the store book in which such accepted goods have been recorded.

Col (6) The balance due should be recorded. It should equal the difference between the disposal price agreed to on hire purchase or credit sale and the amount payable in advance in respect of the goods. The ledger page on which the amount so due was entered, should be recorded.

Col (7) The period for payment of the balance should be described in "weeks", "months", "quarterly periods", "half-yearly periods" or "years", as appropriate.

Col (8) The total number of instalments required to pay off the balance due appearing in Col (6) should be entered.
