THE POLICE ORDINANCE, 1967
(Ordinance No. 9 of 1967).

REGULATIONS MADE UNDER SECTION 9.

ORDINANCE

(Cap. 333 and 7 of 1960 - Laws of Cyprus—
and Ordinance 5 of 1966).

ORDER MADE UNDER SECTION 2.

In exercise of the powers vested in him by section 2 of the Motor Vehicles (Third Party Insurance) Ordinance, the Administrator has been pleased to make the following Order:—

THE AGRICULTURAL PRODUCE (EXPORT)
REGULATIONS, 1956 to 1959.

NOTICE UNDER REGULATION 20 (d).

In exercise of the powers conferred upon me by paragraph (d) of Regulation 20 of the Agricultural Produce (Export) Regulations, 1956 to 1959, as applied to and adapted in the Areas by the Laws (Adaptation and Interpretation) Ordinance, 1960 to 1962, I, the Chief Officer, Sovereign Base Areas, hereby fix Monday the 13th November, 1967, as the date for the commencement of the picking of the 1967/1968 grapefruit intended for export.

THE WELLS ORDINANCE
(Cap. 351 - Laws of Cyprus)

ORDER BY THE ADMINISTRATOR UNDER SECTION 4.

In exercise of the powers conferred upon him by section 4 of the Wells Ordinance, the Administrator hereby defines for the purposes of the said section the area set out in the Schedule hereto as an area in which no permit for the sinking or construction of a well shall be issued and no variations or modification of any condition or restriction imposed on any such permit shall be effected, save with the concurrence of the Chief Officer, in accordance with the provisions of the said section.

2. Notice under section 4(2) of the Wells Ordinance in respect of this Order was published in Supplement No. 3 to the Gazette of 27th October, 1967.

SCHEDULE

The boundary commences at the point where the boundary of the Sovereign Base Area of Dhekelia crosses the old boundary of the Larnaca and Famagusta Districts on the Survey Plan No. XXXII.42 and proceeds in a northerly direction along the boundary of the Sovereign Base Area of Dhekelia, up to the point where the boundary in question crosses the main Pergamos-Lefkoniko road; thence in a southerly direction along the said main road, to a point where this road crosses the old boundary of the Larnaca and Famagusta Districts; thence in a westerly direction along the old boundary of Larnaca and Famagusta Districts to the point of commencement, all which said boundary is shown edged red on the Survey Plan Serial No. 2018.
