**THE MOTOR VEHICLES AND ROAD TRAFFIC
ORDINANCE**

(Cap. 332 - Laws of Cyprus - and Ordinances 6 of 1961,
15 of 1962, 11 of 1965 and 4 of 1966).

REGULATIONS MADE UNDER SECTION 3 (1).

In exercise of the powers vested in him by sub-paragraph (d) of subsection (1) of Section 3 of the Motor Vehicles and Road Traffic Ordinance, the Administrator hereby makes the following Regulations:—

1. These Regulations may be cited as the Motor Vehicles (Amendment) (No. 3) Regulations, 1967, and shall be read as one with the Motor Vehicles Regulations, 1959 to 1967 (hereinafter referred to as “the principal Regulations”).

2. Regulation 58 of the principal Regulations is hereby amended by deleting sub-paragraph (t) of paragraph (1) thereof and substituting therefor the following new sub-paragraph:—

“(t) upon a warning given by a police officer either orally with or without the aid of loud hailing equipment or in the form of a visible warning given by means of a notice requiring him to stop, stop the motor vehicle and wait until he is allowed to proceed by a police officer;”.
