THE CONTROL (ENTRY, SETTLEMENT AND
COMMERCIAL ENTERPRISES) ORDINANCE,
1960 AND 1971

(Ordinances 5 of 1960 and 5 of 1971).

REGULATIONS MADE UNDER SECTION 23.

In exercise of the powers vested in him by Section 23 of the Control (Entry, Settlement and Commercial Enterprises) Ordinance, 1960, the Administrator hereby makes the following Regulations :—

1. These Regulations may be cited as the Control (Entry, Settlement and Commercial Enterprises) (Business Licences) (Amendment) Regulations, 1974.

2. Regulation 4 of the principal Regulations is hereby repealed and replaced by the following :—

“4. The fee for a Business Licence shall be £5. A Business Licence shall be issued on or after the first day of January and shall expire on the thirty-first day of December in every year. Every Business Licence shall be exhibited in a conspicuous place in the licensed premises. No Business Licence shall be transferable.”

3. These Regulations shall come into force as from the 1st day of January, 1975, without prejudice to anything done or left undone under the principal Regulations.

THE PUBLIC RIVERS PROTECTION ORDINANCE

(Cap. 82—Laws of Cyprus).

ORDER MADE BY THE ADMINISTRATOR UNDER SECTION 3.

In exercise of the powers vested in him by section 3 of the Public Rivers Protection Ordinance, the Administrator hereby makes the following Order:—

1. This Order may be cited as the Kouris River (Protection) Order, 1974.
2. That section of Kouris river which runs through the Sovereign Base Area of Akrotiri up to its estuary is hereby declared to be a river for the purposes of the Public Rivers Protection Ordinance.

THE PUBLIC RIVERS PROTECTION ORDINANCE

(Cap. 82—Laws of Cyprus).

NOTICE UNDER SECTION 5 (1).

Whereas that section of Kouris river which runs through the Akrotiri Sovereign Base Area has been declared under Public Instrument No. 50 of 1974 to be a river for the purpose of the Public Rivers Protection Ordinance ;

Now, therefore, notice is hereby given that from the date of the publication of this Notice in the Gazette—

- (a) the removal or carrying away of stones, shingle, gravel, sand, soil or other substance from the bed, bank or wall of the said river is prohibited without a written permit from the Area Officer ;
- (b) the dumping of any rubble, rubbish, sweepings or other refuse in the bed or upon any bank or wall of the said river is prohibited.
