**THE POWERS AND DUTIES (OFFICERS OF THE  
REPUBLIC OF CYPRUS) ORDINANCE**

(Ordinances 2 of 1960, 3 of 1961 and 19 of 1966).

**ORDER MADE UNDER SECTION 3.**

In exercise of the powers conferred upon him by Section 3 of the Powers and Duties (Officers of the Republic of Cyprus) Ordinance, and of all other powers enabling him in that behalf, the Administrator hereby makes the following Order—

1. This Order may be cited as the Powers and Duties (Officers of the Republic of Cyprus) (Amendment) (No. 3) Order, 1976 and shall be read as one with the Powers and Duties (Officers of the Republic of Cyprus) Order, as amended from time to time (hereinafter referred to as "the principal Order").

ORDINANCE

(Ordinances 14 of 1964, 8 of 1965 and 6 of 1975).

REGULATIONS MADE UNDER SECTION 9.

---

In exercise of the powers vested in him under Section 9 of the Water Supply (Special Measures) Ordinance, the Administrator hereby makes the following Regulations :—

1. These Regulations may be cited as the Water Supply (Special Measures) (Amendment) Regulations, 1976, and shall be read as one with the Water Supply (Special Measures) Regulations, 1966, (hereinafter referred to as “the principal Regulations”).

2. Regulation 5 of the principal Regulations is hereby amended :—

- (i) by renumbering the said Regulation as paragraph (1);
- (ii) by inserting immediately thereafter the following new paragraph to be numbered (2) :—

“(2) Every permit granted under the Water Supply (Special Measures) Ordinance shall be issued in Form D, modified by the inclusion of a reference to the section of the said Ordinance under which the permit is granted.”.

THE PUBLIC ROADS (PROTECTION) ORDINANCE

(Cap. 83—Laws of Cyprus—and Ordinance 27 of 1961).

AUTHORISATION UNDER SECTION 9.

In exercise of the powers conferred upon me by Section 9 of the Public Roads (Protection) Ordinance and of all other powers enabling me in that behalf, I, the Chief Officer, Sovereign Base Areas, hereby amend the Schedule to Public Instrument No. 9 of 1973, as amended by Public Instrument No. 33 of 1975, as follows :—

1. In Part I by adding under columns 1 and 2 respectively the following roads at Episkopi Garrison :
