THE COMMODITIES AND SERVICES  
(REGULATION AND CONTROL) ORDINANCE

(Ordinances 11 of 1962, 9 of 1963,  
3 of 1967 and 10 of 1972).

CONTROL AND MAXIMUM PRICE ORDER  
MADE UNDER SECTIONS 3(1) AND 4(1).

---

In exercise of the powers vested in him by subsection (1) of Sections 3 and 4 of the Commodities and Services (Regulation and Control) Ordinance, the Administrator hereby makes the following Order :—

1. This Order may be cited as the Commodities and Services (Maximum Price of Bread) Order, 1979.

2. In this Order —

“bread” means the product produced by baking flour unmixed with any substance other than water, salt and yeast or other leaven and which is of the type known as “psomi” or “ekmek”.

3. Bread is hereby declared to be a controlled commodity to be controlled and regulated under the provisions of the Ordinance.

4. The maximum price at which bread may be sold or offered for sale in the Areas shall not exceed eighty (80) mils for each kilo.

5. Public Instruments Nos. 8 of 1963 and 30 of 1974 are hereby revoked.

THE CRIMINAL PROCEDURE ORDINANCE

(Cap. 155 — Laws of Cyprus — Ordinances 4 of 1960,  
19 of 1963, 1 of 1966, 2 of 1972, 2 of 1973,  
10 of 1975 and 4 of 1978).

THE CRIMINAL PROCEDURE  
(AMENDMENT) (No. 2) RULES, 1979.

RULES OF COURT MADE UNDER SECTION 176.

In exercise of the powers vested in him under Section 176 of the Criminal Procedure Ordinance, the Administrator, with the advice and assistance of the Senior Judge, hereby makes the following Rules of Court :—

2. These Rules of Court may be cited as the Criminal Procedure (Amendment) (No. 2) Rules, 1979 and shall be read as one with the Criminal Procedure Rules as amended from time to time (hereinafter referred to as “the principal Rules”).

3. The principal Rules are hereby amended by revoking Part III thereof and substituting therefor the following new Part :—

“PART III — COSTS OF PROSECUTION.

20.—(1) Costs of every witness called to give evidence in every public prosecution (including any appeal) shall consist of an allowance for attendance (including the time necessarily occupied in travelling to and from the Court) and of an allowance for transport as may be approved by general or special direction of the Court.

(2) In exercising its powers under sub-rule (1) of this Rule, the Court may take into account the Rules and practice both in the Republic of Cyprus and in England :

Provided that, without the approval of the Senior Judge, no costs shall be awarded of a greater amount than an amount (taking into consideration currency values and relative costs of living where appropriate) that would currently be payable in the same circumstances in either the Republic of Cyprus or England.

(3) Notwithstanding anything contained in sub-rule (1) of this Rule, where it appears to the Court that a witness has not suffered any financial loss by reason of his attendance, the Court shall either make no order for costs of attendance or, if it is satisfied that the reason that the witness suffered no such loss was due to the fact that his emoluments continued to be paid by his employer during the period of attendance, may order that such payment as would otherwise have been paid to the witness shall be paid to his employer.

21. The Senior Judge, may give directions to the Chief Police Officer and the Registrars with regard to the forms or other documents which should be submitted by prosecuting Officers to the Registrars in respect of witnesses' costs and the duties of the Registrars upon receipt of such forms or documents.

22. The foregoing provisions shall also apply to witnesses for the defence whose costs are directed by the Court to be paid under the provisions of the Ordinance, to be paid out of the public revenue of the Administration or a person by whom, in the opinion of the Court, the charge was preferred or whom the Court considers responsible for having procured the same."

4. The principal Rules are hereby amended by revoking Appendix 'D' thereto.
