THE LAND ACQUISITION ORDINANCE

(Cap. 226 — Laws of Cyprus — and Ordinances
12 of 1963 and 9 of 1964).

NOTICE UNDER SECTIONS 2, 3 AND 5.

Whereas it has been represented to the Administrator that it is desirable to augment the domestic water supply of Trakhoni village (a village which lies partly within the Sovereign Base Areas and partly within the Republic of Cyprus) by means of obtaining additional water from a borehole which lies within the Akrotiri Sovereign Base Area ;

And whereas, furthermore, it is, in the opinion of the Administrator, in the public interest to assist and collaborate with the appropriate authorities of the Republic of Cyprus in conserving and improving water supplies in the Island of Cyprus ;

And whereas, therefore, it is, in the opinion of the Administrator, desirable for public purposes to augment the domestic water supply of Trakhoni village :

Now, therefore, in exercise of the powers vested in him by Sections 2, 3 and 5 of the Land Acquisition Ordinance, the Administrator does hereby declare the improvement of the water supply of Trakhoni village to be an undertaking of public utility and does hereby entrust the acquisition of the land required for the said undertaking to the Chief Officer, Sovereign Base Areas.

THE LAND ACQUISITION ORDINANCE

NOTICE UNDER SECTION 6.

With reference to Public Instrument No. 20 in Supplement No. 3 to the Gazette of 26th April, 1982, notice is hereby given that the following land is required for the undertaking of public utility mentioned therein :—

The privately-owned immovable property lying within the Sovereign Base Area of Akrotiri situated in the village of Kolossi under and in relation to plot No. 21 (part) of the official Survey Plan LVIII/41 comprising 1400 square feet or thereabouts and shown coloured red on the plan dated 10th April, 1982.

Any person claiming to have any right or interest in the said land who objects to the acquisition is required, within ten days from the date of the publication of this notice, to send me a statement of his right and interest and of the evidence thereof, and of any claim made by him in respect of such right or interest.

The Administrator is willing to treat for the acquisition of the said land.

A plan showing the land described above is available for inspection at the Area Office, Sovereign Base Area, Akrotiri.
