THE MOTOR VEHICLES AND ROAD TRAFFIC
REGULATIONS, 1973.

THE MOTOR VEHICLES AND ROAD TRAFFIC
REGULATIONS, 1973.

APPOINTMENT OF PERSONS TO EXERCISE POWERS
UNDER REGULATION 47.

In exercise of the powers vested in the Registrar of Motor Vehicles by regulation 47 of the Motor Vehicles and Road Traffic Regulations, I, the Registrar of Motor Vehicles, hereby amend the Schedule to Public Instrument No. 41 of 1982, as amended by Public Instruments Nos. 58/82, 5/83, 15/83, 26/83 and 30/83, by the insertion after the name David George Hirst of the names Stewart Dale and Alex Stephen Hone.

ANNUAL HOLIDAYS WITH PAY ORDINANCE

(Ordinances 10 of 1973, 12 of 1979 and 21 of 1980).

REGULATIONS MADE UNDER SECTION 9.

In exercise of the powers conferred upon him by Section 9 of the Annual Holidays with Pay Ordinance 1973 the Chief Officer hereby makes the following Regulations:—

1. These Regulations may be cited as the Annual Holidays with Pay Regulations (Amendment) Regulations, 1983 and shall be read as one with the Annual Holidays with Pay Regulations, 1980 (hereinafter referred to as "the principal Regulations").

P. I. No. 101/80.

2. Regulation 5 of the principal Regulations is hereby amended by deleting the second proviso to paragraph (1) thereof and substituting therefor the following new proviso:

Provided further that no contribution shall be payable in relation to any amount of wages exceeding the maximum weekly or monthly rate of insurable earnings prescribed from time to time under the Social Insurance (Facilitation of Republican Social Insurance Scheme) Ordinance, 1980."

3. The principal Regulations are hereby amended by inserting immediately after Regulation 9 thereof the following new Regulation to be numbered 9A:—

"9A. For the purpose of determining the eligibility of an employee to holiday pay, any contribution which an employer has failed to pay in contravention of these Regulations shall be regarded as being payable where an employer's liability to pay such a contribution has been confirmed by a Court decision."

4. These Regulations shall be deemed to have come into operation on the 4th April, 1983 with the exception of Regulation 3 which shall be deemed to have come into operation on the 6th October, 1980.

THE SOCIAL INSURANCE (FACILITATION OF
REPUBLICAN SOCIAL INSURANCE SCHEME)
ORDINANCE, 1980

(Ordinances 16 of 1980 and 1983).

REGULATIONS MADE BY THE ADMINISTRATOR
UNDER SECTION 18.

In exercise of the powers conferred upon him by Section 18 of the Social Insurance (Facilitation of Republican Social Insurance Scheme) Ordinance, 1980 the Administrator hereby makes the following Regulations :—

1. These Regulations may be cited as the Social Insurance (Contributions) (Amendment) Regulations, 1983 and shall be read as one with the Social Insurance (Contributions) Regulations, 1980 as amended by the Social Insurance (Contributions) (Amendment) Regulations, 1982 (hereinafter referred to as “the principal Regulations”).

67/80 and 55/82.

2. Regulation 8 of the principal Regulations is hereby amended by deleting paragraph (1) thereof and substituting therefor the following new paragraph :—

“8.—(1) The maximum limit of insurable earnings shall be one hundred and eighteen pounds weekly (£118), five hundred and ten pounds monthly (£510) or six thousand and one hundred and twenty pounds annually (£6,120).”.

3. The principal Regulations are hereby amended by inserting immediately after Regulation 8, the following new Regulation to be numbered 8A :—

“8A. For the purposes of calculating the sum of contributions payable for each contribution period or part thereof with regard to the employment of a port worker, the maximum amount of insurable earnings shall be the maximum amount of annual insurable earnings in force from time to time, but where a port worker is employed by two or more employers within the same contribution period, such two or more employers shall be regarded as one employer.”.

4. The principal Regulations are hereby amended by deleting Regulation 9 thereof and substituting therefor the following new Regulation :—

“9. The weekly amount of basic insurable earnings shall be nineteen pounds and six hundred mils (£19.600 mils) and the annual amount thereof one thousand nineteen pounds and two hundred mils (£1019,200 mils).”.

5. Regulation 17 (as amended by P. I. No. 55/82) of the principal Regulations is hereby amended :—

- (a) by deleting the words "the product of the weekly amount of basic insurable earnings multiplied by the factor" appearing in the second, third and fourth lines of paragraph (2) thereof and substituting therefor the words "as set out"; and
- (b) by inserting immediately after the word "application" appearing in the second line of paragraph (5) thereof the words "on the form prescribed by the Chief Officer,".

6. The principal Regulations are hereby amended by deleting the Schedule thereto and substituting therefor the new Schedule appearing in these Regulations.

7. These Regulations shall be deemed to have come into operation on the 4th April, 1983 with the exception of Regulation 3 of these Regulations which shall be deemed to have come into operation on 4th January, 1983.

† The weekly amount of earnings of clergymen, whose weekly earnings are in excess of the amount referred to above, shall be their actual wages upto the maximum limit of insurable earnings."
