#### THE COURTS ORDINANCE

(Ordinances 3 of 1960, 7 of 1961, 19 of 1962, 5 of 1963, 3 of 1965, 9 of 1977 and 12 of 1984).

#### RULES OF COURT UNDER SECTION 63.

In exercise of the powers vested in him by Section 63 of the Courts Ordinance, 1960 and of all other powers enabling him in that behalf, the Administrator hereby makes the following Rules of Court:—

S.L. Vol. II p. 120, P Is. Nos. 321/54, 549/56 and 225/58 (Cyprus) P. Is. Nos. 65/66, 61/69, 7/73, 12/74, 88/76, 8/79 and 13/83.

- 1. These Rules may be cited as the Civil Procedure (Amendment) Rules, 1988 and shall be read as one with the Civil Procedure Rules as amended from time to time (hereinafter referred to as "the principal Rules").
- 2. The heading of Order 65 is hereby amended by deleting the figure "£1,000" appearing therein and substituting therefor the figure "£5,000".
- 3. Rule 1 of Order 65 is hereby amended by deleting in the second line thereof the words "One thousand" and substituting therefor the words "Five thousand".
  - 4. Rule 14(1) of Order 65 is hereby amended as follows:-
  - (a) by deleting the full stop in the last line thereof and substituting therefor a comma, and
  - (b) by adding immediately thereafter, the words "subject to the provisions of sub-paragraph (3) below".
  - 5. Rule 14 (3) of Order 65 is hereby amended as follows:—
  - (a) by deleting the words and comma "If the defendant fails to deliver his defence within the time limited therefor by the writ of summons", appearing therein; and
  - (b) by deleting the word "the" appearing immediately thereafter and substituting therefor the word "The".
- 6. These Rules shall be deemed to have come into operation on 1st January, 1988.

1. This Order may be cited as the Powers and Duties (Officers of the Republic of Cyprus) (Consolidation) (Amendment of Schedule) Order, 1988 and shall be read as one with the Schedule to the Powers and Duties (Officers of the Republic of Cyprus) (Consolidation) Ordinance, 1976 as amended from time to time (hereinafter referred to as "the principal Order").

# THE INDUSTRIAL TRAINING AUTHORITY (REPUBLIC OF CYPRUS) (RECOGNITION) ORDINANCE, 1979

(Ordinances 1 of 1979 and 20 of 1980).

REGULATIONS MADE BY THE ADMINISTRATOR UNDER SECTIONS 9 AND 15.

In exercise of the powers conferred upon him by Sections 9 and 15 of the Industrial Training Authority (Republic of Cyprus) (Recognition) Ordinance, 1979, the Administrator hereby makes the following Regulations:—

P. Is. Nos. 39/79, 87/79, 102/80, 49/83, 38/84, 18/85 and 39/86.

- 1. These Regulations may be cited as the Industrial Training Authority (Employers' Levy) (Amendment) Regulations, 1988 and shall be read as one with the Industrial Training Authority (Employers' Levy) Regulations, 1979 as amended from time to time (hereinafter referred to as "the principal Regulations").
- 2. Regulation 4 of the principal Regulations is hereby amended by deleting the first proviso to paragraph (1) thereof and substituting therefor the following new proviso:—

"Provided that no levy shall be payable in respect of any part of wages exceeding one hundred and seventy pounds weekly or seven hundred and thirty eight pounds monthly.".

3. These Regulations shall be deemed to have come into effect on the 1st April, 1987.
