THE LAND ACQUISITION ORDINANCE

(Cap. 226 — Laws of Cyprus —
and Ordinances 12 of 1963, 9 of 1964,
1 of 1986, 4 of 1987 and 19 of 1988).

NOTICE UNDER SECTIONS 2, 3 AND 5.

Whereas it has been represented to the Administrator that it is desirable to widen the road between Ormidhia and Xylophagou villages, in the Sovereign Base Area of Dhekelia, between BP 22 and BP 377 ;

And whereas it is, in the opinion of the Administrator desirable, for public purposes, to widen the road as aforesaid ;

Now, therefore, in exercise of the powers vested in him by Sections 2, 3 and 5 of the Land Acquisition Ordinance, the Administrator does hereby declare the widening of the Ormidhia - Xylophagou road to be an undertaking of public utility and does hereby entrust the acquisition of the land required for the said undertaking to the Chief Officer, Sovereign Base Areas.

ORDER MADE UNDER SECTIONS 2 AND 6
READ WITH SECTION 29(a) OF THE
INTERPRETATION ORDINANCE
(CAP. 1 — LAWS OF CYPRUS).

In exercise of the powers vested in him by Sections 2 and 26 of the Game and Wild Birds (Protection and Development) Ordinance, 1974 read with Section 29(a) of the Interpretation Ordinance (Cap. 1 — Laws of Cyprus), the Administrator hereby amends the Order appearing as Public Instrument No. 62 of 1988, published in the Gazette No. 824 of the 3rd October, 1988 by deleting paragraph (b) of the Schedule thereto and substituting therefor the following new paragraph —

“(b) The period between 26th December, 1988 to 31st December, 1988 both days inclusive”.

ORDER MADE UNDER SECTION 6
READ WITH SECTION 29(a) OF THE
INTERPRETATION ORDINANCE
(CAP. 1—LAWS OF CYPRUS).

In exercise of the powers conferred upon me under Section 6 of the Game and Wild Birds (Protection and Development) Ordinance, 1974 read with Section 29(a) of the Interpretation Ordinance, (Cap. 1 — Laws of Cyprus), I, the Chief Officer hereby amend the Order appearing as Public Instrument No. 73 of 1988, published in the Gazette No. 827 of the 2nd November, 1988 by deleting paragraph (5) thereof and substituting therefor the following new paragraph —

“(5) This Order covers the period between 6th November, 1988 to 25th December, 1988 inclusive”.
