NOTICE UNDER SECTION 6.

With reference to Public Instrument No. 28 of 1989 in Supplement No. 3 to the Gazette No. 842 of 28th March, 1989, notice is hereby given that the following private immovable property is required for the undertaking of public utility mentioned therein :

The private immovable property within the Sovereign Base Area of Dhekelia, in the Village area of Akhna, Famagusta District, under and in connection with plot 2/1 (part) of the Government Survey Plan XXXII 62 W.1.

### NOTICE UNDER SECTION 6.

1. With reference to Public Instrument No. 25 in Supplement No. 3 to the Gazette No. 840 of 4 March, 1989, notice is hereby given that the following private immovable property and easements are required for the undertaking of public utility mentioned therein :—

FUGITIVE OFFENDERS (DESIGNATED COMMONWEALTH  
COUNTRIES) ORDER, 1989.

In exercise of the powers vested in him by subsection (1) of Section 2 of the Fugitive Offenders Act, 1967 as extended to the Sovereign Base Areas of Akrotiri and Dhekelia by the Fugitive Offenders (Sovereign Base Areas of Akrotiri and Dhekelia) Order, 1967, the Administrator, with the approval of the Secretary of State, hereby makes the following Order :—

1. This Order may be cited as the Fugitive Offenders (Designated Commonwealth Countries) Order, 1989.
  2. Brunei, The Maldives and Vanuatu are hereby designated for the purposes of Section 1 of the Fugitive Offenders Act, 1967 as extended to the Sovereign Base Areas of Akrotiri and Dhekelia by the Fugitive Offenders (Sovereign Base Areas of Akrotiri and Dhekelia) Order, 1967.
