THE LAND ACQUISITION ORDINANCE

(Cap. 226 — Laws of Cyprus — and Ordinances 12 of 1963, 9 of 1964, 1 of 1986, 4 of 1987 and 19 of 1988).

NOTICE UNDER SECTION 6.

1. With reference to Public Instrument No. 25 in Supplement No. 3 to the Gazette No. 840 of 4 March, 1989, notice is hereby given that the following private immovable property is required for the undertaking of public utility mentioned therein :

The private immovable property within the Akrotiri Sovereign Base Area in the village of Sotira under Plot No. 74/1 of the Government Survey Plan LIII. 51 of Sotira village.

2. The land area of the above immovable property comprises 4 decares and is shown red on the relative plan kept at the Area Office Phassouri, Sovereign Base Area Akrotiri.
