**THE MINES AND QUARRIES (REGULATION)  
ORDINANCE**

(Cap. 270 – Laws of Cyprus – Ordinance 14 of 1963).

REGULATIONS MADE BY THE ADMINISTRATOR  
UNDER SECTION 47.

In exercise of the powers vested in the Administrator by Section 47 of the Mines and Quarries (Regulation) Ordinance and of all other powers enabling him in that behalf, the Administrator hereby makes the following Regulations:—

1. These Regulations may be cited as the Mines and Quarries (Amendment) Regulations, 1990 and shall be read as one with the Mines and Quarries Regulations, 1958, as amended from time to time (hereinafter referred to as “the principal Regulations”).

2. The principal Regulations are hereby amended by deleting Regulation 8 thereof and substituting therefor the following new Regulation:

“8.—(1) The expenditure by the holder for prospecting alone shall be as follows:

A. By the holder of prospecting permit Class A—

B. By the holder of prospecting permit Class B—

(2) Where after the expiration of a prospecting permit another prospecting permit is granted to the same holder in respect of the same area or part thereof, the expenditure

regarding such area shall be £3,000.00 cents for a Class “A” permit or £2,000.00 cents for a Class “B” permit for each square kilometre or part thereof for every six monthly period covered by the permit.”.

3. Regulation 36 of the principal regulations is being amended by the deletion of the proviso thereof.

4. The principal Regulations are hereby amended by deleting the Second Schedule thereto and substituting therefor the following new Second Schedule:

## “SECOND SCHEDULE

### The Mines and Quarries (Regulation) Ordinance

(Cap. 270 — Laws of Cyprus — Ordinance 14 of 1963).

### RENTS

1. By the holder of a prospecting permit Class “A” there shall be paid—

£70.00	cents per square kilometre or part thereof .....	for the first year of the permit.
£70.00	cents per square kilometre or part thereof .....	for the 1st renewal of the permit for six months.
£70.00	cents per square kilometre or part thereof .....	for the 2nd renewal of the permit for six months.
£70.00	cents per square kilometre or part thereof .....	for the 3rd renewal of the permit for six months.
£70.00	cents per square kilometre or part thereof .....	for the 4th renewal of the permit for six months.
£70.00	cents per square kilometre or part thereof .....	for the 5th renewal of the permit for six months.
£70.00	cents per square kilometre or part thereof .....	for the 6th renewal of the permit for six months.

2. By the holder of a prospecting permit Class “B” there shall be paid—

£52.00	cents per square kilometre or part thereof .....	for the first year of the permit.
£52.00	cents per square kilometre or part thereof .....	for the 1st renewal of the permit for six months.
£52.00	cents per square kilometre or part thereof .....	for the 2nd renewal of the permit for six months.

3. By the lessee of a mining lease there shall be payable :
  - a. On the issue of a permit £300.00 cents.
  - b. £300.00 per annum paid as rent for the lease of every half square kilometre or part thereof.
4. By the holder of a Quarry licence Class "A" there shall be payable :
  - a. On the issue of a licence £50.00 cents.
  - b. £400.00 per annum paid as rent for the lease of every half square kilometre or part thereof.

Provided that where the extent of the area is less than 10 hectares the fee shall be £250.00 cents.

5. By the holder of a Quarry licence Class "B" there shall be payable :
  - a. On the issue of a licence £25.00 cents.
  - b. £5.00 per annum paid as rent for the lease of every decare or part thereof.

6. By the holder of a Quarry Licence of either Class "A" or "B", a rent of £5.00 cents for every decare or part thereof shall be payable, in addition to the rent specified in paragraphs 4 or 5 of this Schedule as may in each case be determined by the Chief Officer towards the protection of the environment.

7. By the lessee of a mining lease, there shall be payable in addition to the rent specified in paragraph 3 above, a further rent of £200.00 cents for every half square kilometre or part thereof towards the protection of the environment.

8. By the lessee of a mining lease or the holder of a Quarry licence of either Class "A" or "B", an amount of money to be determined in proportion to the extent of the respective privilege and of the expenditure relating to dealing with environmental encumbrances, shall be payable as a guarantee.

9. Where after the expiration of a prospecting permit a new prospecting permit is granted to the same holder for the same area the rent regarding such area shall be :

- £140.00 cents for a prospecting permit Class "A" or
- £70.00 cents for a prospecting permit Class "B"

per square kilometre or part thereof for each six-monthly period of the permit.

10. Where a new prospecting permit granted as in the preceding paragraph 9 hereof provided, covers apart from the same area or part thereof, any additional area, the rent regarding such additional area shall be as specified in the preceding paragraph 9 hereof.

11. Where any area covered by a quarry licence Class "A" or "B" comprises any Crown land the holder of such licence shall pay in addition to the rent specified in paragraphs 4, 5 or 6 of this Schedule, a rent of £10.00 cents per decare or part thereof.
