**THE MOTOR VEHICLES  
(THIRD PARTY INSURANCE) ORDINANCE**

(Cap. 333 and 7 of 1960 — Laws of Cyprus — and Ordinances  
5 of 1966, 15 of 1987, 8 of 1988 and 18 of 1989).

**ORDER MADE BY THE ADMINISTRATOR  
UNDER SECTION 2.**

**No. 25****THE LAND ACQUISITION ORDINANCE**

**NOTICE UNDER SECTIONS 2, 3 AND 5.**

---

Whereas it has been represented to the Administrator that it is desirable to construct public roads outside the affected area of the Agricultural Land Consolidation area in the village of Kolossi in the Sovereign Base Area of Akrotiri;

And whereas it is, in the opinion of the Administrator desirable, for public purposes, to construct the roads as aforesaid;

Now, therefore, in exercise of the powers vested in him by Sections 2, 3 and 5 of the Land Acquisition Ordinance, the Administrator does hereby declare the construction of the aforesaid roads to be an undertaking of public utility and does hereby entrust the acquisition of the land required for the said undertaking to the Chief Officer, Sovereign Base Areas.
