(Ordinances 14 of 1980, 16 of 1987, 20 of 1988, 12 of 1991
and 7 of 1994).GRANT OF LAND UNDER SECTION 18.

THE FOREST ORDINANCE

(Ordinances 14 of 1980, 16 of 1987, 20 of 1988, 12 of 1991
and 7 of 1994).

ORDER UNDER SECTION 22.

In exercise of the powers vested in him under Section 22 of the Forest Ordinance, the Administrator hereby makes the following Order:-

1. This Order may be cited as the Private Forests (Control of Tree Felling) Order, 1994.
2. The cutting down, uprooting, conversion to timber and removal from any private land of any oak or pistachia, save under a licence issued by the Chief Officer, shall be prohibited.
3. The validity of this Order shall expire on the 31st October, 1995.

THE LAND ACQUISITION ORDINANCE

(Cap.226 - Laws of Cyprus - and Ordinances 12 of 1963, 9 of 1964, 1 of 1986, 4 of 1987, 19 of 1988 and 10 of 1993).

NOTIFICATION UNDER SECTION 7.

Whereas by Public Instrument No. 64 published in Supplement No. 3 to the Gazette No. 1031 of the 27th September 1994, the Administrator declared the acquisition of certain land within that part of Episkopi and Akrotiri villages lying within the Akrotiri Sovereign Base Area for the purpose of constructing public roads to be an undertaking of public utility;

And whereas the Area Officer Akrotiri, in compliance with subsection (1) of Section 6 of the Land Acquisition Ordinance by Public Instrument No. 66 of 1994 gave particulars of the land required in connection with the said undertaking of public utility (hereinafter referred to as "the property");

And whereas the Area Officer Akrotiri, in compliance with subsection (2) of the said Section forwarded to the Administrator the required recommendations, plan and particulars;

And whereas the Administrator has approved the plan and particulars submitted and has considered it expedient having regard to the circumstances of the case, that the property be acquired;

Now, therefore, in exercise of the powers vested in him by Section 7 of the Land Acquisition Ordinance, the Administrator hereby sanctions the acquisition of the property under the provisions of the said Ordinance.
