**ANNUAL HOLIDAYS WITH PAY ORDINANCE**

**REGULATIONS MADE UNDER SECTION 9.**

---

In exercise of the powers conferred upon him by Section 9 of the Annual Holidays with Pay Ordinance, 1973 the Chief Officer hereby makes the following Regulations:-

1. These Regulations may be cited as the Annual Holidays with Pay (Amendment) Regulations, 1995 and shall be read as one with the Annual Holidays with Pay Regulations, 1980 (hereinafter referred to as "the principal Regulations").

2. Regulation 9A of the principal Regulations is hereby amended by deleting the words "has been confirmed by a Court decision" appearing in the fifth and sixth lines thereof and substituting therefor the following words "has been determined by the Chief Officer".

3. These Regulations shall be deemed to have come into operation on the 1st May 1995.
