THE MOTOR VEHICLES AND ROAD TRAFFIC ORDINANCE
(Ordinances 8 of 1973, 5 of 1982, 2 of 1983 and 11 of 1985).

REGULATIONS MADE UNDER SECTION 3(g).

In exercise of the powers vested in him by paragraph (g) of Section 3 of the Motor Vehicles and Road Traffic Ordinance, 1973 the Administrator hereby makes the following Regulations:-

1. These Regulations may be cited as the Motor Vehicles (One-Way Traffic) Regulations, 1995 and shall be read as one with the Motor Vehicles (One-Way Traffic) Regulations, 1986 as amended from time to time (hereinafter referred to as "the principal Regulations").

2. The principal Regulations are hereby amended by the addition in columns 1 and 2 respectively in Part II of the Schedule "DHEKELIA AREA", of the following:-

Column 1	Column 2

Roundabout on Larnaca View Road / Crimea Road.	Clockwise.

**THE MOTOR VEHICLES AND ROAD

ORDER UNDER SUB-SECTION (2) OF SECTION 4

In exercise of the powers conferred upon me by subsection (2) of Section 4 of the Motor Vehicles and Road Traffic Ordinance 1973, I, the Chief Officer, hereby make the following Order:-

1. This Order may be cited as the Speed Limits (Amendment) Order 1995 and shall be read as one with the Speed Limits Order 1989 (hereinafter referred to as 'the principal Order').

2. Part II of the Schedule to the principal Order is hereby amended as follows :-

In Part II, DHEKELIA AREA by adding the following new entry :-
