**NOTICE UNDER SECTIONS 2, 3 AND 5.**

---

Whereas it has been represented to the Administrator that it is desirable for military purposes to provide for the passage of water to the Sovereign Base Area of Akrotiri through the village of Kolossi and for certain rights, easements and privileges safeguarding the carrying out of certain works in relation thereto;

And whereas it is, in the opinion of the Administrator, desirable for military purposes to lay, use and maintain a water pipeline as aforesaid;

Now therefore in exercise of the powers vested in him by Sections 2, 3 and 5 of the Land Acquisition Ordinance, the Administrator has been pleased to declare the laying of a water pipeline to be an undertaking of public utility and to authorise the carrying out of the said undertaking and entrusts the acquisition of the land required for the said undertaking to the Chief Officer, Sovereign Base Areas.
