THE PRISONS (GENERAL) REGULATIONS, 1993

No. 63**THE GAME AND WILD BIRDS (PROTECTION AND DEVELOPMENT) ORDINANCE, 1974**

(Ordinances 11 of 1974, 1 of 1982, 3 of 1985, 9 of 1988, 20 of 1989, 13 of 1991 and 15 of 1993).

ORDER MADE UNDER SECTION 6

In exercise of the powers conferred upon me under Section 6 of the Game and Wild Birds (Protection and Development) Ordinance, 1974, I, the Acting Chief Officer, hereby order as follows:-

1. This Order may be cited as the Game (Ceiling) Order, 1996.
2. The number of hares that may be shot or possessed by the holder of a game licence shall not on any one day exceed two.
3. The number of partridges that may be shot or possessed by the holder of a game licence shall not on any one day exceed five.
Provided that such holder may on any one day shoot or possess one francolin, but in such a case the number of partridges that may be shot or possessed by such holder shall not on any one day exceed four.
4. Nothing in this Order shall apply to the possession of hares, partridges or francolin by any person who is entitled to possess such game under Section 11 of the Ordinance.
5. This Order covers the period between 3rd November, 1996 and 31st December, 1996 inclusive.

THE LAND ACQUISITION ORDINANCE

(Cap.226 - Laws of Cyprus - and Ordinances 12 of 1963,
9 of 1964, 1 of 1986, 4 of 1987, 19 of 1988 and 10 of 1993)

NOTICE UNDER SECTIONS 2, 3 AND 5.

Whereas it has been represented to the Administrator that it is desirable to widen and maintain the section of the road between Ormidhia and Akhna Forest within the Sovereign Base Area of Dhekelia:

And whereas it is, in the opinion of the Administrator desirable, for public purposes, to widen and maintain the road as aforesaid;

Now, therefore, in exercise of the powers vested in him by Sections 2, 3 and 5 of the Land Acquisition Ordinance, the Administrator does hereby declare the widening and maintaining of the Ormidhia-Akhna Forest road within the Sovereign Base Area of Dhekelia to be an undertaking of public utility and does hereby entrust the acquisition of the land required for the said undertaking to the Chief Officer, Sovereign Base Areas.

**THE MOTOR VEHICLES AND ROAD TRAFFIC
ORDINANCE**

(Ordinances 8 of 1973, 5 of 1982, 2 of 1983, and 1 of 1985).

ORDER UNDER SUBSECTION (2) OF SECTION 4.

In exercise of the powers conferred upon me by subsection (2) of Section 4 of the Motor Vehicles and Road Traffic Ordinance 1973, I, the Chief Officer, hereby make the following Order:-

1. This Order may be cited as the Speed Limits (Amendment) Order, 1996 and shall be read as one with the Speed Limits Order, 1989 (hereinafter referred to as "the principal Order").

2. Paragraph (1) of Part II of the Schedule to the principal Order is hereby amended to read as follows:-

AUTHORIZATION UNDER SECTION 9
