THE CRIMINAL PROCEDURE ORDINANCE
(Cap.155 - Laws of Cyprus - Ordinances 4 of 1960, 19 of 1963,
1 of 1966, 2 of 1972, 2 of 1973, 10 of 1975, 4 of 1978, 11 of 1979,
22 of 1987, 4 of 1992 and 8 of 1996).

THE CRIMINAL PROCEDURE (AMENDMENT) RULES

RULES OF COURT MADE UNDER SECTION 176.

In exercise of the powers vested in him under Section 176 of the Criminal Procedure Ordinance, the Administrator, with the advice and assistance of the Senior Judge, hereby makes the following Rules of Court:-

2. These Rules of Court may be cited as the Criminal Procedure (Amendment) Rules, 1996, and shall be read as one with the Criminal Procedure Rules as amended from time to time (hereinafter referred to as "the principal Rules").

3. Paragraph (a) of Rule 9A of the principal Rules is hereby amended -

- (a) by deleting the semi colon appearing immediately after the word "occupation" thereof and substituting therefor a colon.
- (b) by inserting immediately thereafter the following new proviso:-

"Provided that where the accused is a member of the Force or civilian component or a dependant thereof, as defined in Section 1 of Annex C of the Treaty of Establishment, whose British Forces Post Office address is known, by sending it to him at that address by ordinary post in a sealed plain envelope properly addressed and marked "Personal and Private" and giving a return address with a Post Office Box number of the sender".

4. Appendix A to the principal Rules is hereby amended by deleting Form No. 11 thereof and substituting therefor the new Form No. 11 entitled "Affidavit of Service" as set out in the Appendix to these Rules.
