THE WATER SUPPLY (SPECIAL MEASURES) ORDINANCE
(Ordinances 14 of 1964, 8 of 1965, 6 of 1975 and 15 of 1991).

ORDER MADE BY THE ADMINISTRATOR UNDER SECTION 3(1)

In exercise of the powers vested in him by section 3(1) of the Water Supply (Special Measures) Ordinance, the Administrator hereby declares the area specified in the Schedule hereto to be a controlled area and thereupon the provisions of this Ordinance shall apply to such area in respect to the matters by this Ordinance provided.

SCHEDULE

Defined Area

In the village of Sotira in the District of Limassol within the Sovereign Base Area of Akrotiri, the area within the following boundary, that is to say:-

The boundary commences at the point where the north-western boundary of Plot No. 355 of Sheet/Plan 53/42 and the northern boundary of the Sovereign Base Area of Akrotiri meet, then proceeds south along the western boundary of Plot Nos. 355, 81, 24, 25, 37, 41 and 46 of Sheet/Plan 53/42 then eastward along the southern boundary of Plot 46 and south along the western boundary of the same plot and then eastward along the southern boundary of Plot 45/2 of Sheet/Plan 53/42, then eastward along the southern boundary of Plot No. 55 of Sheet/Plan 53/42 and Plot Nos. 48 and 56 of Sheet/Plan 53/51 then north along the eastern boundaries of Plot Nos. 56, 57, 58, 59, 47, 46/2, 45, 118, 117, 19/1, 19/2, 133, 19/4, 18, 17/1, 17/2, 121, 16/2, 14 and 13 of Sheet/Plan 53/51 and 259, 258/1, 241/4 and 241/1 of Sheet/Plan 53/43 and then west along the northern boundary of the Sovereign Base Area of Akrotiri to the point of commencement, all of which is more particularly delineated on a plan marked Serial No. SBA/1/97 signed by the Acting Chief Officer dated 8th May, 1997 and deposited in the Area Office of Akrotiri Sovereign Base Area.
