THE FORESHORE PROTECTION ORDINANCE, 1975
(Ordinance 9 of 1975).

ORDER MADE BY THE ADMINISTRATOR UNDER SECTION 9.

In exercise of the powers conferred upon him by section 9 of the Foreshore Protection Ordinance, 1975 the Administrator hereby makes the following Order:-

P.I.No.43/77

1. This Order may be cited as the Foreshore Protection (Prescription of Forms) (Amendment) Order, 1997 and shall be read as one with the Foreshore Protection (Prescription of Forms) Order (hereinafter referred to as "the principal Order").

2. The Second Schedule to the principal Order is hereby revoked and replaced by the following new Schedule:

SECOND SCHEDULE

**FEES PAYABLE IN RESPECT OF PERMITS ISSUED
AS PROVIDED IN PARAGRAPHS 2 TO 5 OF ORDER**

	Per annum or part thereof
(a) For the erection of a hut/booth/or other structure on Crown land:	
(1) Area of 100 square metres or part thereof.....	£150,00
(2) Area exceeding 100 square metres.....	£600,00
(b) For the erection of hut/booth or other structure on private land.	
(1) Area of 100 square metres or part thereof.....	£10,00
(2) Area exceeding 100 square metres.....	£40,00
(c) For the placing of a boat.....	£75,00
(d) For the placing of chairs, tables or other objects.....	£150,00
(e) For the organisation or carrying out of a sporting event	£45,00
per month or part thereof.

THE SUMMER TIME ORDINANCE
(Cap.98 - Laws of Cyprus).

ORDER MADE UNDER SECTION 2(1).

In exercise of the powers vested in him by subsection (1) of Section 2 of the Summer Time Ordinance, the Administrator hereby makes the following Order:-

1. This Order may be cited as the Summer Time Order, 1998.
2. In the period specified in the Schedule hereto, the time for legal and general purposes in the Areas shall be three hours in advance of Greenwich Mean Time.

SCHEDULE

From 01.00 hours (Greenwich Mean Time) on the 29th March, 1998 to 01.00 hours (Greenwich Mean Time) on the 25th October, 1998.
