No. 23**THE IMMOVABLE PROPERTY (TENURE, REGISTRATION
AND VALUATION) ORDINANCE**

(Cap. 224 - Laws of Cyprus - and Ordinances 52 of 1996,
11 of 1984, 1 of 1985, 12 of 1985, 5 of 1987, 18 of 1987,
21 of 1988, 8 of 1990, 14 of 1990, 13 of 1993 and 4 of 1996).

NOTIFICATION UNDER SECTION 27(1B).

In exercise of the powers vested in the Chief Officer by the proviso to section 27(1B) of the Immovable Property (Tenure, Registration and Valuation) Ordinance, I the Chief Officer, hereby specify that in the Land Consolidation area of Ypsonas to which P.I. No. 14 of 1993 promulgated in Supplement No.3 of the SBA Gazette No. 987 of 15th March, 1993 refers, instead of the minimum extents of the areas of plots as provided in paragraphs (a) and (b) of the said section, the minimum extents provided by paragraphs (b) and (c) of subsection (1) of section 27 shall apply respectively.

THE MOTOR VEHICLES (THIRD PARTY INSURANCE)
ORDINANCE

(Cap. 333 and 7 of 1960 - Laws of Cyprus - and Ordinances

and 1 of 1995).

ORDER MADE BY THE ADMINISTRATOR UNDER SECTION 2.

In exercise of the powers vested in him by section 2 of the Motor Vehicles (Third Party Insurance) Ordinance, the Administrator hereby makes the following Order:-

1. This Order may be cited as the Motor Vehicles (Third Party Insurers) (Consolidation) (Amendment) Order 1998 and shall be read as one with the Motor Vehicles (Third Party Insurers) (Consolidation) Order 1994 (hereinafter referred to as "the principal Order").

2. Paragraph 2 of the principal Order is hereby amended by inserting in the appropriate alphabetical order the following new Insurance Company :-
