THE LAND ACQUISITION ORDINANCE
(Cap. 226 - Laws of Cyprus - and Ordinances 12 of 1963,
9 of 1964, 1 of 1986, 4 of 1987, 19 of 1988 and 10 of 1993).

NOTICE UNDER SECTION 6.

With reference to Public Instrument No. 66 of 16th July 1999 published in Supplement No.3 to the Gazette No. 1156 of 16th July 1999, notice is hereby given that the following rights, easements, privileges and liberties are required for the undertaking of the public utility mentioned therein.

Rights, easements, privileges and liberties for the purpose of and in connection with the laying, using and maintaining freely and uninterruptedly by the Acquiring Authority of a water pipeline, in over or under the following privately-owned immovable property within the Sovereign Base Area of Dhekelia, in the village of Dherynia, Famagusta District, under and in connection with plot No. 375 (part) of the Government Survey Plan XXXIII.26E2, plot No. 342/1(part), 343/2 (part), 340 (part), 338 (part), 337 (part), 336 (part), of the Government Survey Plan XXXIII.34E1.

The land area of the above immovable properties comprises 912 sq. metres or thereabouts and is shown coloured green on the relative plan kept at the Area Office, Sovereign Base Areas Administration, Dhekelia.

Any person claiming to have any right or interest in the said land who objects to the acquisition of the said rights, easements, privileges and liberties, is required within fifteen days from the date of publication of this notice, to send to me a statement of his right and interest and of the evidence thereof and of any claim made by him in respect of such right or interest.

The Administrator is willing to treat for the acquisition of the said rights, easements, privileges and liberties.

A set of plans showing the land described above is available for inspection at the Area Office, Sovereign Base Areas Administration, Dhekelia.

Public Instrument No.67/99 published in Gazette No. 1156 of 16 July 1999 is hereby revoked.

THE CUSTOMS AND EXCISE ORDINANCE 1969
(Ordinances 12 of 1969, 9 of 1971, 2 of 1975, 4 of 1977,
8 of 1977, 20 of 1987, 19 of 1989 and 9 of 1991)

ORDER MADE BY THE ADMINISTRATOR UNDER SECTION 129 (2).

In exercise of the powers vested in him under subsection (2) of section 129 of the Customs and Excise Ordinance 1969, the Administrator hereby makes the following Order:-

1. This Order may be cited as the Customs and Excise (Marketing and Sale of Manufactured Tobacco Licensing) (Amendment) Order 1999 and shall be read as one with the Customs and Excise (Marketing and Sale of Manufactured Tobacco Licencing) Order 1970 (hereinafter referred to as "the principal Order").

2. The Schedule to the principal Order is hereby amended by deleting the figure and words "£1.500 mils" appearing at the end thereof and substituting therefor the figure "£10.00".

THE FOREST ORDINANCE
(Ordinances 14 of 1980, 16 of 1987, 20 of 1988,
12 of 1991 and 7 of 1994).

ORDER UNDER SECTION 22.

In exercise of the powers vested in him under section 22 of the Forest Ordinance, the Administrator hereby makes the following Order:-

1. This Order may be cited as the Private Forests (Control of Tree Felling) Order 1999.
 2. The cutting down, uprooting, conversion to timber and removal from any private land of any oak or pistachia, save under a licence issued by the Chief Officer, shall be prohibited.
 3. The validity of this Order shall expire on the 1st May 2001.
