THE POLICE ORDINANCE

(Ordinances 9 of 1967, 14 of 1969, 7 of 1975, 2 of 1993
and 10 of 1998)

ORDER MADE UNDER SECTION 23(1)

In exercise of the powers vested in me by section 23(1) of the Police Ordinance, I, the Chief Constable of the Sovereign Base Areas hereby order that the Paphos-Limassol dual carriage way (High-way) between the tunnel and Sotira overbridge shall be closed to all vehicular traffic from 0900 hours on 8/3/2000 until 1200 hours on the same date. Vehicular traffic travelling on the above road will be diverted through Paramali exit on the old Limassol-Paphos road.

**REGULATIONS MADE UNDER SUBSECTION (2) OF SECTION 15
OF THE PRISONS ORDINANCE 1971, READ WITH SECTION 9
OF THE POLICE ORDINANCE 1967 AND SECTION 12
OF THE PRISONS ORDINANCE**

In exercise of the powers vested in me by subsection (2) of section 15 of the Prisons Ordinance, read with section 9 of the Police Ordinance, and section 12 of the Prisons Ordinance, I, the Chief Constable, with the approval of the Administrator, hereby make the following Regulations:-

1. These Regulations may be cited as the Police and Prison Officers (General) (Amendment) Regulations 2000, and shall, where they apply to the Police (General) Regulations 1967, as amended from time to time, (hereinafter referred to as "the principal Police Regulations"), be read as one with those Regulations, and where they apply to the Police (General) Regulations 1967 as modified by paragraph 2 and Appendix II of Public Instrument No.60 of 1971 and thereby made applicable to, and made to relate to, the service of prison officers, be read as one with such Regulations as so modified, which are hereinafter referred to as "the principal Prison Officers Regulations".

THE LAND ACQUISITION ORDINANCE

(Cap.226 - Laws of Cyprus - and Ordinances 12 of 1963, 9 of 1964, 1 of 1986, 4 of 1987, 19 of 1988 and 10 of 1993).

NOTIFICATION UNDER SECTION 7.

Whereas by Public Instrument No.92/99 published in Supplement No. 3 to the Gazette No. 1164 of the 29 October 1999 the Administrator declared the installation of services for the Dhekelia-Protaras Highway, Pyla-Xylotymbou Section, through the Dhekelia Sovereign Base Area to be an undertaking of public utility;

And whereas the Area Officer, Dhekelia, in compliance with subsection (1) of section 6 of the Land Acquisition Ordinance and by Public Instrument No. 93/99 published in Supplement No.3 to the Gazette No.1164 of the 29 October 1999 gave particulars of the land to be acquired in connection with the said undertaking of public utility (hereinafter referred to as "the land");

And whereas the Area Officer, Dhekelia, in compliance with subsection (2) of the said section, forwarded to the Administrator the required recommendations, plans and particulars;

And whereas the Administrator has approved the plans and particulars submitted and has considered it expedient, having regard to the circumstances of the case, that the land be acquired;

Now, therefore, in exercise of the powers vested in him by section 7 of the Land Acquisition Ordinance, the Administrator hereby sanctions the acquisition of the land under the provisions of the said Ordinance.
