**THE WATER SUPPLY (SPECIAL MEASURES)
ORDINANCE**

(Ordinances 14 of 1964, 8 of 1965, 6 of 1975 and 15 of 1991)

**ORDER MADE BY THE ADMINISTRATOR UNDER
SECTION 3(1)**

In exercise of the powers vested in him by section 3(1) of the Water Supply (Special Measures) Ordinance, the Administrator hereby declares the area defined in the Schedule hereto to be a controlled area and thereupon the provisions of this Ordinance shall apply to such area in respect to the matters by this Ordinance provided.

SCHEDULE

Defined Area

In the village of Paramali, within the Sovereign Base Area of Akrotiri, the area within the following boundary, that is to say:-

The boundary which commences at the point of Paramali Forest Cairn No.46 (F.C. No.46), on the eastern boundary of plot no. 38 of Sheet/Plans LIII/57 & LVIII/1; then proceeds northwards, successively along the said plot boundary and the boundary of plot no. 253 of Sheet/Plan LIII/57, up to the point of Paramali Forest Cairn No.50 (F.C. No.50); then across the said plot no. 253 and the registered road abutting on it; then successively along parts of the boundaries of plot nos. 46, 45, 46, 48, 397 and 379 of the same Sheet/Plan; then across the registered road abutting on the said plot no. 379 and successively along parts of the boundaries of the Limassol-Paphos motorway and of plot nos. 376, 367 and 368 of the same Sheet/Plan; then across the registered road abutting on the said plot no. 368 and successively along parts of the boundaries of plot nos. 276 and 81 of the same Sheet/Plan; then across river Pharkonias and successively along parts of the boundaries of plot nos. 369, 89, 369 and 371; then across the Limassol-Paphos motorway and successively along parts of the boundaries of plot nos. 444, 443, 119, 125, 319, 123 and 333 of the same Sheet/Plan; then westwards, along the northern boundary of the registered road abutting on the southern boundary of the said plot no. 333 and successively along parts of the boundaries of plot no. 324 of Sheet/Plans LIII/57 & LII/64 and of plot nos. 351, 350, 397, 357, 359, 361, 364, 339, 329, 330, 331, 332 and 334 of Sheet/Plan LII/64; then across the registered road abutting on the southern boundary of the said plot 334 and successively along parts of the boundaries of plot nos. 335, 170, 171, 200, 201, 202, 379 and 380 of the same Sheet/Plan; then successively along parts of the boundaries of plot no. 188 of Sheet/Plans LVII/8 & LII/64 and of plot nos. 295, 296, 423, 424, 421, 422, 300, 396, 302, 303, 302, 399, 398, 339, 409, 410 and 336 of Sheet/Plan LVII/8; then successively along parts of the boundaries of plot nos. 412, 335 and 191/1 of Sheet/Plans LVII/8 & LVIII/1; then southwards, successively along the boundaries of river Farkonias and of plot no. 206 of Sheet/Plan LVIII/1; then across river Farkonias and successively along parts of the boundaries of plot nos. 205,

204, 201, 158, 268, 156, 155, 136, 202, 125, 259, 258, 122, 254, 108, 251, 106, 108, 111, 101 and 100 of the same Sheet/Plan; then, northwards, along the eastern boundary of plot no. 38 of Sheet/Plans LVIII/57 & LVIII/1, up to the point of commencement.

The said area is more particularly delineated and hatched blue on the Plans under Serial Nos. AO(A)/SM(PA)/01, AO(A)/SM(PA)/02, AO(A)/SM(PA)/03 and AO(A)/SM(PA)/04 attached hereto, which have been signed and sealed by the Chief Officer Sovereign Base Areas on the 17th day of September 2004 and deposited at the Area Office Akrotiri.
