

No. 27**THE PETROLEUM ORDINANCE 1976**

(Ordinance 1 of 1976 as amended by Ordinance 26 of 2000)

REGULATIONS MADE UNDER SECTION 9

In exercise of the powers vested in him by section 9 of the Petroleum Ordinance 1976^(a) as amended by section 3 of the Petroleum (Amendment) Ordinance 2000^(b), and under section 28A of the Interpretation Ordinance^(c) the Administrator hereby makes the following Regulations:—

Citation

1. These Regulations may be cited as the Petroleum (Amendment) Regulations 2005.

Adoption of Republican Regulations

2.—(1) Subject to the provisions of these Regulations, each of the Republican instruments (“the Republican Regulations”) named in column 1 of the Table below, which came into force in the Republic on the date shown in column 2 in relation to it, is adopted under the Petroleum Ordinance 1976 and accordingly, as from the date that these Regulations come into force, the provisions of the Republican Regulations shall have effect in the Areas (so far as relevant) as if they had been made under section 9 of the Petroleum Ordinance 1976.

3. The Petroleum (Amendment) Regulations 2000^(b) and the Petroleum (Amendment) Regulations 2004^(c) are revoked.
