

No. 73**THE BETTING HOUSES, GAMING HOUSES AND
GAMBLING PREVENTION (CONSOLIDATION)
ORDINANCE 1985**

(Ordinance 10/85 as amended by Ordinances 1/96,
30/05 and 18/06)

REGULATIONS MADE UNDER SECTION 6A

In exercise of his powers under section 6A of the Betting Houses, Gaming Houses and Gambling Prevention (Consolidation) Ordinance 1985 as amended^(a), the Administrator hereby makes the following Regulations:—

Citation and commencement

1. These Regulations may be cited as the Betting Houses, Gaming Houses and Gambling Prevention (Kazandi) Regulations 2006 and shall come into force on the day of their publication in the Gazette.

Interpretation

2. In these Regulations,

“kazandi permit” means a permit issued under section 6A of the Ordinance;

“the Ordinance” means the Betting Houses, Gaming Houses and Gambling Prevention (Consolidation) Ordinance 1985 as amended.

Application for kazandi permit

3. An application for a kazandi permit shall be made in the form set out in Schedule 1.

Form of kazandi permit

4. A kazandi permit shall be issued in the form set out in Schedule 2.

Conditions of kazandi permit

5. A kazandi permit issued in accordance with section 6A of the Ordinance shall be issued subject to the following conditions –

- (a) The value of any monetary or other prize may not exceed £30;
- (b) The maximum amount payable in order to participate in a game may not exceed £5 for each card;
- (c) The value of any non-monetary prize must be written legibly on the card;
- (d) The amount payable in order to win a particular category of non-monetary prize must be written legibly in respect of each such category;

(a) Section 6A was inserted by section 3 of the Betting Houses, Gaming Houses and Gambling Prevention (Consolidation)(Amendment) Ordinance 2005 (30/05) and amended by section 3 Betting Houses, Gaming Houses and Gambling Prevention (Consolidation)(Amendment) Ordinance 2006 (18/06).

- (e) The non-monetary prizes of the game of kazandi must be placed on the kazandi appliance;
- (f) The kazandi appliance must be operated openly;
- (g) The hours of operation may only be between 9.00 a.m. of one day and 03.30 a.m. of the following day;
- (h) The game played must be the traditional game of kazandi and may not be in any electronic form;
- (i) A person under the age of 16 years must not be allowed to participate in the game of kazandi unless he is accompanied by at least one of his parents;
- (j) Only 1 kazandi permit may be issued per person;
- (k) The kazandi permit shall be displayed prominently at the place where the kazandi to which it relates is being played.

Fee payable

6. The fee payable for an annual kazandi permit is £120.

Revocation

7. Regulation 12^(b) (“Conditions for licensing of “kazandi””) of the Amusement Machines (Registration and Licensing) Regulations 1966 is revoked.

 - (b) The maximum amount payable in order to participate in a game may not exceed £5 for each card;
 - (c) The value of any non-monetary prize must be written legibly on the card;
 - (d) The amount payable in order to win a particular category of non-monetary prize must be written legibly in respect of each such category;
 - (e) The non-monetary prizes of the game of kazandi must be placed on the kazandi appliance;
 - (f) The kazandi appliance must be operated openly;
 - (g) The hours of operation may only be between 9.00 a.m. of one day and 03.30 a.m. of the following day;
 - (h) The game played must be the traditional game of kazandi and may not be in any electronic form;
 - (i) A person under the age of 16 years must not be allowed to participate in the game of kazandi unless he is accompanied by at least one of his parents;
 - (j) The kazandi permit shall be displayed prominently at the place where the kazandi game to which it relates is being played.
