

**No. 84****THE VIOLENCE IN THE FAMILY ORDINANCE 2003**

(Ordinance 21/03 as amended by Ordinance 21/06)

**RULES MADE UNDER SECTION 31**

In exercise of his powers under section 31 of the Violence in the Family Ordinance 2003 as amended by section 15 of the Violence in the Family (Amendment) Ordinance 2006 the Administrator, with the advice and assistance of the Senior Judge, hereby makes the following Rules:—

**Citation and commencement**

1. These Rules may be cited as the Violence in the Family Rules 2006 and shall come into force on the day of their publication in the Gazette.

**Forms**

2. The forms specified in the Schedule, or forms to the like effect, shall be used where applicable with such variations as the circumstances of the particular case may require or as the Senior Court Registrar may direct.

**Application for interim order under section 22**

3. An application for an interim order in accordance with section 22 shall be made without notice in Form 1.

**Modification or revocation of exclusion order**

4. An application for the modification or revocation of an exclusion order in accordance with section 23(3) shall be made on notice in Form 2.

**Objection to application to modify or revoke exclusion order**

5.—(1) An objection to an application for the modification or revocation of an exclusion order in accordance with section 23(3) shall be made on notice in Form 3.

(2) An objection submitted in accordance with paragraph (1) shall be filed with the Senior Court Registrar and served on the person named in the exclusion order not less than 2 days prior to the date fixed for the Court to hear the application for modification or revocation.
