
**INDUSTRIAL TRAINING AUTHORITY (EMPLOYERS' LEVY) (AMENDMENT)
REGULATIONS 2008**

In exercise of his powers under section 16(1)(c) of the Human Resources Development Authority (Republic of Cyprus) Recognition Ordinance 2001(a), the Administrator makes the following Regulations:-

Citation and commencement

1. These Regulations may be cited as the Industrial Training Authority (Employers' Levy) (Amendment) Regulations 2008, and are to be regarded as having come into effect on 1 May 2008(b).

Regulation 4 revoked and replaced

2. Regulation 4 (Fixing the amount of levy) of the Industrial Training Authority (Employers' Levy) Regulations 1979(c) is revoked and replaced by the following new Regulation:

“4. The amount of levy payable by an employer is the same as that payable in the Republic under the Human Resources Development Authority (Employers' Levy) Regulations 2008(d) or under any regulations amending or replacing those Regulations.”.

Revocation

3. Public instruments 49/83, 38/84, 18/85, 39/86, 22/88, 28/88, 22/89, 48/90, 30/91, 22/92, 24/93, 37/93, 25/94, 29/95, 25/96 and 26/02 are revoked.

EXPLANATORY NOTE

(This note is not part of the Regulations)

These Regulations are made under section 16(1)(c) of the Human Resources Development Authority (Republic of Cyprus) Recognition Ordinance 2001. They amend the Industrial Training Authority (Employers' Levy) Regulations 1979 by providing that the amount of levy payable by an employer in respect of each of his employees is the same as that payable by an employer in the Republic under the equivalent Republican regulations in force at the time. An effect of this is that, when the Republican regulations are amended to raise the salary ceiling above which the levy is not payable, the salary ceiling in the Areas will rise by the same amount, without the need for further amendment of the 1979 Regulations. These Regulations also expressly revoke the Industrial Training Authority (Employers' Levy) Regulations 2002 and those public instruments made before it that had no effect other than amending the amount of the employers' levy.

These Regulations have retrospective effect, in that they are to be regarded as having come into effect on 1 May 2008.
