

## SEWERAGE (RECOGNISED BOARD) ORDER 2010

The Chief Officer makes the following Order in exercise of the power under section 3 of the Sewerage Ordinance 2008(a).

### Citation and commencement

1. This Order may be cited as the Sewerage (Recognised Board) Order 2010 and comes into force on the day that it is published in the Gazette.

### Declaration of recognised Board

2. The Sewerage Board of Kokkinokhoria may exercise powers and perform duties in the parts of the Dhekelia Sovereign Base Area identified in the Schedule by references to the official Republic of Cyprus Government survey plans.

## **EXPLANATORY NOTE**

**(This note is not part of the Order)**

### Introduction

1. This explanatory note relates to the Sewerage (Recognised Board) Order 2010 (“the Order”). It has been prepared by the Office of the Attorney General and Legal Adviser in order to assist the reader of the Order. It does not form part of the Order.

### Particular points

2. Section 3 of the Sewerage Ordinance 2008 (“the Ordinance”) provides that the Chief Officer may by Order declare that a sewerage board established under Republican law may exercise powers and perform duties in a specified part of the Areas in accordance with section 4 of the Ordinance. A board exercising functions in the Areas under section 3 is known as a recognised Board.

3. The recognised Board declared in the Order is the sewerage board of Kokkinokhoria which was established in the Republic by publication of Public Instrument 111/2010 in Official Gazette number 4417 of the Republic of 12 March 2010. The specified parts of the Areas are set out in the Schedule and the references are to the official Republic of Cyprus Government survey plans. The specified parts of the Areas are outlined in yellow and blue on the plans which are available for consultation during office hours at the Dhekelia Area Office.
