**LAND ACQUISITION (SANCTION OF ACQUISITION) (DESALINATION PLANT)
NOTIFICATION 2010**

In exercise of the powers under section 7 of the Land Acquisition Ordinance(a), the Administrator, having approved the plan and particulars submitted to him under section 6 of that Ordinance and considering it expedient, having had regard to all of the circumstances of the case, that the land referred to in article 2 should be acquired, makes the following notification.

Citation and commencement

1. This notification may be cited as the Land Acquisition (Sanction of Acquisition) (Desalination Plant) Notification 2010 and comes into force on the day it is published in the Gazette.

Sanction of acquisition

- 2.** The acquisition of the private land specified in paragraph 2 of the Schedule, is sanctioned—
- (a) in the case of the private immovable property relating to the plot numbers and villages specified in paragraphs 2(a) to (d) of the Schedule, for the construction and operation of a desalination plant and for construction of public roads providing access to it; and
 - (b) in the case of the private immovable property relating to the plot numbers and villages specified in paragraphs 2(e) and (f) of the Schedule, for the acquisition of rights, easements, privileges and liberties for the purposes of laying, use and maintenance of a water pipeline associated with the desalination plant.

Schedule

1. In this Schedule—

“Plan 1” means Sheet/Plan 58/05 marked “SBA/AK/LDP/CA/AN/Plan 1” dated 7 July 2010 and available for inspection at the Area Office Akrotiri during normal office hours;

“Plan 2” means Sheet/Plan 58/06 (Agios Loukas) marked “SBA/AK/LDP/CA/AN/Plan 2” dated 7 July 2010 and available for inspection at the Area Office Akrotiri during normal office hours;

“Plan 3” means Sheet/Plan 58/13 marked “SBA/AK/LDP/CA/AN/Plan 3” dated 7 July 2010 and available for inspection at the Area Office Akrotiri during normal office hours;

“Plan 4” means Sheet/Plan 58/21 marked “SBA/AK/LDP/CA/AN/Plan 4” dated 7 July 2010 and available for inspection at the Area Office Akrotiri during normal office hours; and

“Plan 5” means Sheet/Plan 58/21W1 marked “SBA/AK/LDP/CA/AN/Plan 5” dated 7 July 2010 and available for inspection at the Area Office Akrotiri during normal office hours.

2. The land specified is the private immovable property amounting to approximately 38,844 square metres and comprising—

- (a) the whole of plot nos. 2 and 161 in Akrotiri Village shaded in yellow on Plan 4;
- (b) those parts of plot no. 1 in Akrotiri Village shaded in red, and plot no. 160 in Akrotiri Village shaded in orange, on Plan 4;
- (c) part of plot no. 3 of Block 2 in Akrotiri Village shaded in orange on Plan 5;
- (d) part of plot nos. 142, 143 and 156 in Episkopi Village shaded in red and plot nos. 66, 154 and 155 in Episkopi Village shaded in orange on Plan 3;
- (e) those parts of plot nos. 276, 371, 390, 391, 392, 446 and 447 in Erimi Village shaded in green on Plan 1; and
- (f) those parts of plot nos. 166, 167, 193, 432, 481, 485, 486, 487, 488, 489, 490, 491, 593, 594, 608, 609, 611, 613, 614, 615, 628, 640, 642 and 887 in Kolossi Village shaded in green on Plan 2.
