**LAND ACQUISITION (SANCTION OF ACQUISITION) (TRAHONI ROAD  
IMPROVEMENT) NOTIFICATION 2010**

---

In exercise of the powers under section 7 of the Land Acquisition Ordinance<sup>(a)</sup>, the Administrator, having approved the plans and particulars submitted to him under section 6 of that Ordinance and considering it expedient, having had regard to all of the circumstances of the case and considering that the land referred to in article 2 should be acquired, makes the following notification:

**Citation and commencement**

1. This notification may be cited as the Land Acquisition (Sanction of Acquisition) (Trahoni Road Improvement) Notification 2010 and comes into force on the day it is published in the Gazette.

**Sanction of acquisition**

2. The acquisition of the private land specified in paragraph 2 of the Schedule is sanctioned for the improvement of Konstantinou and Evripidi Avenue in Trahoni village in the Akrotiri Sovereign Base Area.

**Schedule**

1. In this Schedule—

“Plan 1” means that part of Sheet/Plan 58/15W1 of Trahoni village marked “SBA/AK/TRI/CA/P1” dated 3 December 2009 and available for inspection at the Area Office Akrotiri during normal office hours;

“Plan 2” means that part of Sheet/Plan 58/15 of Trahoni village marked “SBA/AK/TRI/CA/P2” dated 27 October 2009 and available for inspection at the Area Office Akrotiri during normal office hours;
2. The land specified is the private immovable property amounting to approximately 4000 square metres and comprising—
  - (a) those parts of plot nos. 474, 475, 777, 1536, 1537, 1541, 1608 and 1680 shaded in red on Plan 1;
  - (b) those parts of plot nos. 42, 43, 47, 62 and 63 shaded in red on Plan 2.
