PORTS (AKROTIRI) DECLARATION ORDER 2011

The Administrator makes this Order in exercise of the powers under section 3 of the Ports Ordinance 2010(a):

Citation, commencement and interpretation

1. (1) This Order may be cited as the Ports (Akrotiri) Declaration Order 2011 and comes into force on 25 May 2011.

(2) In this Order, references to latitudes and longitudes are latitudes and longitudes on the World Geodetic System 1984 Datum.

Declaration of port

2. The place specified in the Schedule is declared to be a port.

Revocation

3. The Ports Ordinance (Declaration of Ports) Order 1987(b) is revoked.

Schedule

1. The seaward areas of the port are the areas of sea within the following lines—
 - (a) the line from the position where the line of latitude 34° 33.80'N intersects the low water mark on the eastern side of the Akrotiri Peninsula to latitude 34° 33.80'N, longitude 33° 03.78'E ("position B"); then
 - (b) the line from position B to latitude 34° 35.00'N, longitude 33° 02.00'E ("position C"); and then
 - (c) the line from position C to the position where the line of latitude 34° 35.00'N intersects the low water mark on the eastern side of the Akrotiri peninsula.
2. The landward areas of the port are those areas of the Akrotiri peninsula within the lines described in the following paragraphs—
 - (a) from latitude 34° 34.22'N longitude 33° 01.97'E to latitude 34° 34.22'N, longitude 33° 01.74'E to latitude 34° 34.48'N, longitude 33° 01.74'E to latitude 34° 34.48'N, longitude 33° 01.88'E;
 - (b) from latitude 34° 34.43'N longitude 33° 01.84'E to latitude 34° 34.43'N, longitude 33° 01.39'E to latitude 34° 34.61'N, longitude 33° 01.39'E to latitude 34° 34.61'N, longitude 33° 01.66'E.

EXPLANATORY NOTE

(This note does not form part of the Order)

1. This explanatory note relates to the Ports (Akrotiri) Declaration Order 2011 (the “Order”). It has been prepared by the Office of the Attorney General and Legal Adviser in order to assist the reader of the Order. It does not form part of the Order.
2. The Order is made under section 3 of the Ports Ordinance 2010 and specifies the landward and seaward limits of the port of Akrotiri.
3. The Order changes the port limits by reducing the seaward extent of the port limits and by extending the port limits to include the petroleum offloading buoy and pipeline and certain areas on the shore.
