**LAND ACQUISITION (SANCTION OF ACQUISITION)(WORKS CONNECTED WITH  
THE VERTICAL ROAD AND KATO POLEMIDHIA WASTE WATER TREATMENT  
PLANT) NOTIFICATION 2013**

---

In exercise of the powers under section 7 of the Land Acquisition Ordinance(a), the Administrator, having approved the plans and particulars submitted to him under section 6 of that Ordinance and considering it expedient, having had regard to all of the circumstances of the case, that the land referred to in article 2 should be acquired, makes the following Notification:

**Citation and commencement**

1. This Notification may be cited as the Land Acquisition (Sanction of Acquisition) (Works Connected with the Vertical Road and Kato Polemidhia Waste Water Treatment Plant) Notification 2013 and comes into force on the day after publication in the Gazette.

**Sanction of acquisition**

2. (1) For the purpose of the works specified in article 2(2) of the Land Acquisition (Works Connected with the Vertical Road and the Kato Polemidhia Waste Water Treatment Plant) Notification 2012(b), the Administrator sanctions—

- (a) the acquisition of the land specified in Schedule 1 shown shaded in red on the plan; and
- (b) the acquisition of such rights, easements, privileges and liberties over the land specified in Schedule 2, shown shaded in green on the plan, as are necessary for the construction, free uninterrupted use, inspection, control and maintenance of storm-water culverts, a waste-water culvert and any subsurface works associated with those culverts.

(2) The plan referred to in paragraph 1 is the plan marked SBA/AOA/CA/PWDC/P and is available for inspection at the Akrotiri Area Office during normal working hours.

- (a) Cap 226, Laws of Cyprus 1959 revised edition. Legislation of the former colony of Cyprus has effect in the Areas by virtue of article 5 of the Sovereign Base Areas of Akrotiri and Dhekelia Order in Council 1960 (UK S.I. 1960/1369). Schedule 2 to the Interpretation Ordinance 2012 (Ord. 8/2012) provides for the interpretation of such legislation. There are amendments to Cap 226 but not to section 7.

## **EXPLANATORY NOTE**

**(This note is not part of the Notification)**

1. This explanatory note relates to the Land Acquisition (Sanction Of Acquisition) (Works Connected with the Vertical Road and Kato Polemidhia Waste Water Treatment Plant) Notification 2013. It has been prepared by the Office of the Attorney General and Legal Adviser in order to assist the reader of the Notification.

2. The Notification sanctions the acquisition of land specified in Schedule 1 and rights, easements etc. over land specified in Schedule 2 for the purpose of undertakings of public utility, namely the construction of -

- (a) storm-water culverts connected with the construction of a public road from the Limassol-Paphos Motorway to Limassol New Port (the “Vertical Road”); and
- (b) a waste-water culvert connected with the construction of a waste water treatment plant, at Kato Polemidhia.
