GAME AND WILD BIRDS (GENERAL GAME  
RESERVES) ORDER 2015

---

The Chief Officer makes the following Order in exercise of the power under section 31(1) of the Game and Wild Birds Ordinance 2008(a)

**Citation, commencement**

1.—(1) This Order may be cited as the Game and Wild Birds (General Game Reserves) Order 2015.

(2) This Order comes into force on the day after it is published in the Gazette.

**Interpretation**

2. In this Order—

- (a) the “Akrotiri SBA map” is the map labelled “SBA/AKR/GGR/TGR/2015” which is available for inspection during normal working hours at the Akrotiri Area Office; and
- (b) the “Dhekelia SBA map” is the map labelled “SBA/DHK/GGR/TGR/2015” which is available for inspection during normal working hours at the Dhekelia Area Office.

**General game reserves**

3. The following areas are designated as general game reserves—

- (a) the area coloured green and labelled R1 on the Akrotiri SBA map (the “South-East general game reserve”);
- (b) the area coloured green and labelled R2 on the Akrotiri SBA map (the “Episkopi general game reserve”);
- (c) the area coloured green and labelled R3 on the Akrotiri SBA map (the “North-West general game reserve”)
- (d) the area coloured green and labelled R4 on the Akrotiri SBA map (the “Evdhimou general game reserve”);
- (e) the area coloured purple on the Dhekelia SBA map (the “Dhekelia general game reserve”).

**Revocations**

4. The following orders are revoked—

- (a) the Game and Wild Birds (General Game Reserves) Order 2009(a);
- (b) the Game and Wild Birds (General Game Reserves) (Amendment) Order 2014(b).

## **EXPLANATORY NOTE**

*(This note is not part of the Order)*

1. This explanatory note relates to the Game and Wild Birds (General Game Reserves) Order 2015 (“the Order”). It has been prepared by the Office of the Attorney General and Legal Adviser in order to assist the reader of the Order, and does not form part of the Order.
2. The Order is made under section 31 of the Game and Wild Birds Ordinance 2008. It designates areas in the Akrotiri Sovereign Base Area and the Dhekelia Sovereign Base Area as general game reserves. General game reserves are areas where hunting is prohibited at all times. The order does not change the areas designated as general game reserves under the Game and Wild Birds (General Game Reserves) Order 2009, but updates references to the maps showing the location of general game reserves. The maps have been changed so as to provide greater clarity as to the areas designated.
3. The map showing the location of the general game reserves in the Akrotiri SBA is available for inspection by the public in the Akrotiri Area Office. The map showing the location of the temporary game reserves in the Dhekelia SBA is available for inspection by the public at the Area Office Dhekelia.
3. The Order revokes the Game and Wild Birds (General Game Reserves) Order 2009, as amended in 2014.
