# GAME AND WILD BIRDS (GENERAL GAME RESERVES) ORDER 2019

The Chief Officer makes the following Order in exercise of the power under section 31(1) of the Game and Wild Birds Ordinance 2008(a):

#### Citation and commencement

- 1.—(1) This Order may be cited as the Game and Wild Birds (General Game Reserves) Order 2019.
  - (2) This Order comes into force on 17 August 2019.

### Interpretation

- 2. In this Order—
  - (a) the "Akrotiri SBA GGR map" is the map in Schedule 1;
  - (b) the "Dhekelia SBA GGR map" is the map in Schedule 2.

### General game reserves

- 3. The following areas are designated as general game reserves—
  - (a) the area coloured green and labelled R1 on the Akrotiri SBA GGR map (the "South-East general game reserve");
  - (b) the area coloured green and labelled R2 on the Akrotiri SBA GGR map (the "Episkopi general game reserve");
  - (c) the area coloured green and labelled R3 on the Akrotiri SBA GGR map (the "North-West general game reserve");
  - (d) the area coloured purple on the Dhekelia SBA GGR map (the "Dhekelia general game reserve").

#### Revocation

**4.** The Game and Wild Birds (General Game Reserves) Order 2017(**b**) and the Game and Wild Birds (General Game Reserves) (Amendment of Schedule) Order 2019(**c**) are revoked.




# SCHEDULE 1 Akrotiri SBA GGR map

#### **EXPLANATORY NOTE**

(This note is not part of the Order)

- 1. This explanatory note relates to the Game and Wild Birds (General Game Reserves) Order 2019 ("the Order"). It has been prepared by the Office of the Attorney General and Legal Adviser in order to assist the reader of the Order, and does not form part of the Order.
- 2. The Order is made under section 31 of the Game and Wild Birds Ordinance 2008 ("the 2008 Ordinance"). It designates areas in the Akrotiri and Dhekelia Sovereign Base Areas as general game reserves, where hunting is prohibited at all times. The order consolidates the Game and Wild Birds (General Game Reserves) Order 2017 and the Game and Wild Birds (General Game Reserves) (Amendment of Schedule) Order 2019.
- 3. The map showing the location of the general game reserves in the Akrotiri SBA is available for inspection by the public at the Akrotiri Area Office. The map showing the location of the general game reserve in the Dhekelia SBA is available for inspection by the public at the Dhekelia Area Office.
- 4. The Order revokes the Game and Wild Birds (General Game Reserves) Order 2017 and the Game and Wild Birds (General Game Reserves) (Amendment of Schedule) Order 2019.
