### **EXPLANATORY NOTE**

(This note is not part of the Order)

- **1.** This explanatory note relates to the Police (Famagusta to Larnaca Main Road)(Traffic Prohibition) (Revocation) Order 2021 ("the Order"). It has been prepared by the office of the Attorney General and Legal Adviser in order to assist the reader of the Order. It does not form part of the Order. This note should be read in conjunction with the Order. It is not, and is not meant to be, a comprehensive description of the Order.
- **2.** This Order provides for the revocation of the Police (Larnaca to Famagusta Main Road) (Traffic Prohibition) Order 2021 and the Police (Larnaca to Famagusta Main Road) (Traffic Prohibition) Order (No.2) 2021 (the Traffic Orders). These Traffic Orders were made under section 24(4) of the Police Ordinance 2007, which permits the Administrator to make an order prohibiting traffic from using a road for such period of time as may be specified in the order.
- **3.** The Traffic Orders prohibit traffic from using a section of the main road between Famagusta and Larnaca, known as Corridor Road, during construction works being carried out on Ayios Nikolaos bridge. The work will be completed on 30 June and therefore the Traffic Orders can be revoked.
